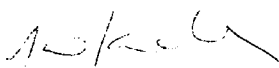

ORDER

UPON READING the application notice dated 15 June 2021

AND UPON READING the evidence

IT IS ORDERED THAT:

1. Where required, the proceedings herein to be transferred to the High Court for the purpose of making the order sought and thereafter to be transferred back to the respective County Court;
2. From the date of this order:
 - 2.1 Philip Francis Duffy and Sarah Helen Bell (together "Outgoing Officers") be removed from office in respect of each of the cases listed in Schedules SHB and PFD (attached to this order) (block transfer cases) from the date of this order and that:

- 2.2 Andrew Knowles is appointed in substitution to Sarah Helen Bell of those matters shown in **Part A of Schedule SHB**;
 - 2.3 Joanne Sara Wright is appointed in substitution to Sarah Helen Bell of those matters shown in **Part B of Schedule SHB**.
 - 2.4 Robert Armstrong is appointed in substitution to Philip Francis Duffy of those matters shown in **Part A of Schedule PFD**;
 - 2.5 Joanne Sara Wright is appointed in substitution to Philip Francis Duffy of those matters shown in **Part B of Schedule PFD**;
 - 2.6 James Saunders is appointed in substitution to Philip Francis Duffy of those matters shown in **Part C of Schedule PFD**;
 - 2.7 Michael Lennon is appointed in substitution to Philip Francis Duffy of those matters shown in **Part D of Schedule PFD**;
 - 2.8 Steven Muncaster is appointed in substitution to Philip Francis Duffy of those matters shown in **Part E of Schedule PFD**;
 - 2.9 Andrew Knowles is appointed in substitution to Philip Francis Duffy of those matters shown in **Part F of Schedule PFD**;
 - 2.10 Allan Watson Graham is appointed in substitution to Philip Francis Duffy of those matters shown in **Part G of Schedule PFD**;
 - 2.11 Robert Armstrong, Joanne Sara Wright, James Saunders, Michael Lennon, Steven Muncaster, Andrew Knowles, and Allan Watson Graham (together "Replacement Officeholders")
 - 2.12 Geoffrey Wayne Bouchier and Paul David Williams both of Kroll Advisory Ltd, The Shard, 32 London Bridge Street, London, SE1 9SG remain as joint appointees of the cases at **Part C of Schedule SHB**
3. The Outgoing Officeholders shall receive their release as either administrator, trustee in bankruptcy, liquidator or supervisor 28 days after the giving of notice to creditors by way of single composite advertisement in the London Gazette and within the next report due to be circulated to creditors (whichever is earlier), save that such release may be subject to further order in the event of an application by any creditor (or member in the case of members' voluntary liquidations) under paragraph 8 of this order for the specific case subject to that application.
 4. The Replacement Officeholders shall notify the Secretary of State and the Registrar of Companies in respect of the liquidations and administration listed in Schedules SHB and PFD of the terms of this order as soon as reasonably practicable.
 5. The creditors in each of the block transfer cases listed in the Schedule be notified of this order by a single composite advertisement in the London Gazette within 28 days of the date of this order and within the next report due to be circulated to creditors (whichever is the earlier). Such advertisement shall state:
 - (1) That Philip Francis Duffy and Sarah Helen Bell have been removed from office and, where relevant, replaced by the relevant Replacement Officeholder;

- (2) that the creditors (or members in the case of members' voluntary liquidations) have liberty to issue an application on notice within 28 days after the date of the report or advertising in the London Gazette, whichever is the earlier to vary or discharge the Order;
 - (3) that Philip Francis Duffy and Sarah Helen Bell will be entitled to apply to the Secretary of State for their release from liability after the enquiry of a period of 28 days commencing with the date of the report or advertising in the London Gazette, whichever is the earliest, in relation to liquidations and bankruptcies; and
 - (4) that Philip Francis Duffy and Sarah Helen Bell will be released from liability in relation to those other matters listed in Schedules SHB and PFD, not covered by sub paragraph (3)(3) above 28 days after the date of the report or advertising in the London Gazette, whichever is the earlier.
6. In the event that the next report due in each matter listed in the Schedules SHB and PFD is due within 28 days of the making of this Order, an extension of a further 56 days after the due date shall be permitted for the drafting and circulation to creditors (or members) in the case of members voluntary liquidations) of each report.
7. Save for any extension of time granted by paragraph 6 of the order, the removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in Schedule SHB and PFD and the current time limit for reporting to creditors on each of the cases shall continue irrespective of the removal and appointments made by this Order.
8. A creditor (or member in the case of members voluntary liquidations) of any of the estates listed in either Schedule SHB and PFD who has an objection to this order shall have 28 days from the date of the report containing the notice referred above or advertisement to apply to court to set aside or vary the terms of the Order, Such application shall not affect the transfer of the block transfer cases listed in the Schedules until further or other order by the court.
9. The Proposals (and resolutions contained therein) to creditors in each administration shall be read as if the relevant Replacement Office Holder was originally stated in place of Philip Francis Duffy or Sarah Helen Bell (as applicable), with the effect of that where Philip Francis Duffy or Sarah Helen Bell was proposed and then resolved to be appointed as liquidator on any subsequent liquidation, the relevant Replacement Office Holder will be deemed to have been resolved to be appointed in his place.
10. Where a Replacement Officeholder is appointed, he or she shall act jointly and severally with their joint office holder, unless the outgoing office holder did not so act, in which case they shall act in the same capacity as the outgoing office holder previously did.
11. In relation to the Insolvency proceedings listed in Schedules SHB and PFD and insofar as the Insolvency Act 1986 or the Insolvency Rules 2016 contains any requirements for advertisement, the requirement shall be dispensed with (subject to further order of the Court). Insofar as the Applicants are required by law to give any notice of the removal from office, the Replacement Office Holder is entitled to sign and send any such notice on their behalf.

12. As soon as reasonably practicable after the making of the order of the Court, the Replacement Office Holders shall file with each of the courts listed in the Schedules a copy of the sealed order.
13. There be no order as to costs.
