SPECIAL RESOLUTION 1

That the articles of association of the Company be amended by the insertion of new clause 22A, namely:

That the A Ordinary shares of £1.00 each in the capital, the B Ordinary shares of £1.00 in the capital, the C Ordinary shares of £1.00 in the capital and the D Ordinary shares of £1.00 in the capital constitute separate classes of share and have the following rights and restrictions attached:

- A right to receive notice of and attend at general meetings of the Company but no right to vote;
- A right to a return of capital on liquidation;
- No right of redemption; and
- A right to receive a dividend and to be considered separately by the Directors of the Company in deciding whether a dividend should be paid.

SPECIAL RESOLUTION 2

That the provisions of Section 561 of the Companies Act 2006 shall not apply to the issue of up to 1000 new A, B, C or D Ordinary shares of £1.00 each in the capital of the company provided such allotment shall take place within 1 months of the date of this resolution.
