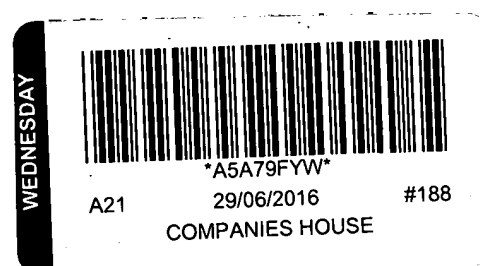

##### **Accounting convention**
