IT IS ORDERED THAT:

- 1 The proposed dissolution date of Sofia Rose Transport Limited (In Liquidation) (the "**Company**") is deferred from 22 September 2023 to 22 March 2024 (the "**Revised Dissolution Date**") subject to the Applicant being at liberty to:
 - 1.1 provide confirmation that no criminal proceedings are to be taken against the Company prior to the Revised Dissolution Date;
 - 1.2 apply for a further deferment of the Revised Dissolution Date if
 - 1.2.1 a decision by the Procurator Fiscal on whether to raise criminal proceedings against the Company has not been made prior to the Revised Dissolution Date; or
 - 1.2.2 criminal proceedings against the Company are ongoing.
- 2 Upon receiving notification that no criminal proceedings are to be taken against the Company, or that any criminal proceedings have been finally concluded, the Applicant shall send such confirmation to the Registrar of Companies by way of post (Crown Way, Cardiff CF14 3UZ) and by email to enquiries@companieshouse.gov.uk.
- 3 Until such time as notification has been provided to the Registrar of Companies, no further steps shall be taken in respect of the dissolution of the Company.
- 4 Liberty to apply to the Respondents to vary or set aside on 7 days' written notice to the Applicant.
- 5 No order as to costs.
