



1 Introduction

- 1.1 I, Paul Davis together with my partner David Buchler, of Buchler Phillips Group LLP, 6 Grosvenor Street, London, W1K 4PZ, were appointed as Joint Liquidators of Hark Preston Limited (the Company) on 2 March 2021. The affairs of the Company are now fully wound-up and this is our final account of the Liquidation, which covers the period since our appointment (the Period).

3 Work undertaken by the Liquidators

- 4.2 There were no known preferential creditors.

Unsecured Creditors

- 4.3 According to the Declaration of Solvency, the Company has no liabilities. A notice to creditors to prove their claims in the Liquidation was advertised in the London Gazette on 4 March 2021 and the last day of proof as 31 March 2021. No claims have been received in the Liquidation and HM Revenue & Customs has confirmed there are no outstanding tax liabilities and have no objection to the conclusion of the Liquidation.

5 Distributions to Members

- 5.1 According to the Declaration of Solvency, there were no assets available for realisation and therefore no distributions were made to the members of the Company.


6 Liquidators' Remuneration

Additional Information in Relation to the Liquidators' Fees & Expenses

Staff Allocation and the use of Subcontractors

The general approach to resourcing our assignments is to allocate staff with the skills and experience to meet the specific requirements of the case.

The constitution of the case team will usually consist of a Partner, a Manager, and an Administrator or Assistant. The exact constitution of the case team will depend on the anticipated size and complexity of the assignment and the experience requirements of the assignment.

We have not utilised the services of any subcontractors in this case.

Professional Advisors

On this assignment we have not used any professional advisors.

Liquidators' Expenses

The estimate of expenses which were anticipated at the outset of the Liquidation was provided to members when the basis of our fees were approved.

Category 1 expenses

These expenses do not require prior approval by members. The type of expenses that may be charged to a case as a Category 1 expense generally comprise of external supplies of incidental services specifically identifiable to the case, such as postage, case advertising, invoiced travel and external printing, external room hire and external storage costs. Also chargeable, will be any properly reimbursed expenses incurred by personnel in connection with the case. These expenses may include disbursements which are payments first met by an office holder and then reimbursed from the estate.


