**1. Defined Terms**

- 1 1 The interpretation of these Articles is governed by the provisions set out in the Schedule at the end of the Articles

**1.2. COMMUNITY INTEREST COMPANY AND ASSET LOCK**

**2. Community Interest Company**

- 2 1 The Company is to be a community interest company

**3. Asset Lock"**

- 3 1 The Company shall not transfer any of its assets other than for full consideration

- 3 2 Provided the conditions in Article 3 3 are satisfied, Article 3 1 shall not apply to

(a) the transfer of assets to any specified asset-locked body, or (with the consent of the Regulator) to any other asset-locked body, and

(b) the transfer of assets made for the benefit of the community other than by way of a transfer of assets into an asset-locked body

- 3 3 The conditions are that the transfer of assets must comply with any restrictions on the transfer of assets for less than full consideration which may be set out elsewhere in the memorandum and Articles of the Company

- 3 4 If

3 4 1 the Company is wound up under the Insolvency Act 1986, and

3 4 2 all its liabilities have been satisfied

#### **5. Objects<sup>iv</sup>**

The objects of the Company are to carry on activities which benefit the community and in particular (without limitation) to

5.1 Young People (Sixth Form 17-19yrs) high ability, high aspiration young people from challenging backgrounds. They will have experienced socio-economic disadvantage, had significant life challenges or come from groups underrepresented in local, national and international leadership It is our belief that left to their own devices these young people could do well, but with the kind of timely intervention this programme offers, they could do great

The exceptional young people we target have the talent to perform at the highest levels in the careers they pursue But they are born into classes and contexts that engineer them out of the opportunities to realise their full potential The City Leadership Programme is the intentional intervention these young people need It will equip them with the skills, tools and connections that will help them overcome these barriers of social immobility

5.2 Our Cities For business it's an investment in the city's leadership talent pool from which they will draw For Universities it an opportunity to invest the future student body And for both its an opportunity to practice a more expansive and progressive kind of leadership, using their business and academic resources, and proving their worth as co-creators of place And for a city as a hole, it is an investment in the diversity of thought that will be needed to meet the challenges of an increasingly complex world and the breadth of representation needed if civic institutions are to retain their democratic legitimacy

#### **6 Powers**

6.1 To further its objects the Company may do all such lawful things as may further the Company's objects and, in particular, but, without limitation, may borrow or raise and secure the payment of money for any purpose including for the purposes of investment or of raising funds

#### **7. Liability of members<sup>v</sup>**

The liability of each member is limited to £1, being the amount that each member undertakes to contribute to the assets of the Company in the event of its being wound up while he or she is a member or within one year after he or she ceases to be a member, for

- 7 1 payment of the Company's debts and liabilities contracted before he or she ceases to be a member,
- 7 2 payment of the costs, charges and expenses of winding up, and
- 7 3 adjustment of the rights of the contributories among themselves

## **DIRECTORS**

### **DIRECTORS' POWERS AND RESPONSIBILITIES<sup>vi</sup>**

#### **8. Directors' general authority**

Subject to the Articles, the Directors are responsible for the management of the Company's business, for which purpose they may exercise all the powers of the Company

#### **9. Members' reserve power**

- 9 1 The members may, by special resolution, direct the Directors to take, or refrain from taking, specific action
- 9 2 No such special resolution invalidates anything which the Directors have done before the passing of the resolution

#### **10. Chair**

The Directors may appoint one of their number to be the chair of the Directors for such term of office as they determine and may at any time remove him or her from office

#### **11. Directors may delegate<sup>vii</sup>**

- 11 1 Subject to the Articles, the Directors may delegate any of the powers which are conferred on them under the Articles or the implementation of their decisions or day to day management of the affairs of the Company

11 1 1 to such person or committee,

11 1 2 by such means (including by power of attorney),

11 1 3 to such an extent.

11 1 4 in relation to such matters or territories, and

11 1 5 on such terms and conditions,

as they think fit

- 11 2 If the Directors so specify, any such delegation of this power may authorise further delegation of the Directors' powers by any person to whom they are delegated
- 11 3 The Directors may revoke any delegation in whole or part, or alter its terms and conditions

## **DECISION-MAKING BY DIRECTORS**

### **12. Directors to take decisions collectively<sup>viii</sup>**

Any decision of the Directors must be either a majority decision at a meeting or a decision taken in accordance with Article 18

### **13. Calling a Directors' meeting**

- 13 1 Two Directors may (and the Secretary, if any, must at the request of two Directors) call a Directors' meeting

- 13 2 A Directors' meeting must be called by at least seven Clear Days' notice unless either

- 13 2 1 all the Directors agree, or

- 13 2 2 urgent circumstances require shorter notice

- 13 3 Notice of Directors' meetings must be given to each Director

- 13 4 Every notice calling a Directors' meeting must specify:

- 13 4 1 the place, day and time of the meeting, and

- 13 4 2 if it is anticipated that Directors participating in the meeting will not be in the same place, how it is proposed that they should communicate with each other during the meeting

- 13 5 Notice of Directors' meetings need not be in Writing

- 13 6 Notice of Directors' meetings may be sent by Electronic Means to an Address provided by the Director for the purpose

### **14. Participation in Directors' meetings**

- 14 1 Subject to the Articles, Directors participate in a Directors' meeting, or part of a Directors' meeting, when

- 14 1 1 the meeting has been called and takes place in accordance with the Articles, and

- 14 1 2 they can each communicate to the others any information or opinions they have on any particular item of the business of the meeting

- 14 2 In determining whether Directors are participating in a Directors' meeting, it is irrelevant where any Director is or how they communicate with each other<sup>ix</sup>

- 14 3 If all the Directors participating in a meeting are not in the same place, they may decide that the meeting is to be treated as taking place wherever any of them is

**15. Quorum for Directors' meetings<sup>x</sup>**

- 15 1 At a Directors' meeting, unless a quorum is participating, no proposal is to be voted on, except a proposal to call another meeting

- 15 2 The quorum for Directors' meetings may be fixed from time to time by a decision of the Directors, but it must never be less than two, and unless otherwise fixed it is three

- 15 3 If the total number of Directors for the time being is less than the quorum required, the Directors must not take any decision other than a decision

15 3 1 to appoint further Directors, or

15 3 2 to call a general meeting so as to enable the members to appoint further Directors

**16. Chairing of Directors' meetings**

The Chair, if any, or in his or her absence another Director nominated by the Directors present shall preside as chair of each Directors' meeting

**17. Decision-making at meetings<sup>xi</sup>**

- 17 1 Questions arising at a Directors' meeting shall be decided by a majority of votes

- 17 2 In all proceedings of Directors each Director must not have more than one vote<sup>xii</sup>

- 17 3 In case of an equality of votes, the Chair shall have a second or casting vote

**18. Decisions without a meeting<sup>xiii</sup>**

- 18 1 The Directors may take a unanimous decision without a Directors' meeting in accordance with this Article by indicating to each other by any means, including without limitation by Electronic Means, that they share a common view on a matter. Such a decision may, but need not, take the form of a resolution in Writing, copies of which have been signed by each Director or to which each Director has otherwise indicated agreement in Writing

- 18 2 A decision which is made in accordance with Article 18 1 shall be as valid and effectual as if it had been passed at a meeting duly convened and held, provided the following conditions are complied with

18 2 1 approval from each Director must be received by one person being either such person as all the Directors have nominated in advance for that purpose or such other person as volunteers if necessary ("the Recipient"), which person may, for the avoidance of doubt, be one of the Directors,

18 2 2 following receipt of responses from all of the Directors, the Recipient must communicate to all of the Directors by any means whether the resolution has been formally approved by the Directors in accordance with this Article 18 2,

18 2 3 the date of the decision shall be the date of the communication from the Recipient confirming formal approval,

18 2 4 the Recipient must prepare a minute of the decision in accordance with Article 32

## **19. Conflicts of interest<sup>xiv</sup>**

19 1 Whenever a Director finds himself or herself in a situation that is reasonably likely to give rise to a Conflict of Interest, he or she must declare his or her interest to the Directors unless, or except to the extent that, the other Directors are or ought reasonably to be aware of it already

19 2 If any question arises as to whether a Director has a Conflict of Interest, the question shall be decided by a majority decision of the other Directors

19 3 Whenever a matter is to be discussed at a meeting or decided in accordance with Article 18 and a Director has a Conflict of Interest in respect of that matter then, subject to Article 20, he or she must

19 3 1 remain only for such part of the meeting as in the view of the other Directors is necessary to inform the debate,

19 3 2 not be counted in the quorum for that part of the meeting, and

19 3 3 withdraw during the vote and have no vote on the matter

19 4 When a Director has a Conflict of Interest which he or she has declared to the Directors, he or she shall not be in breach of his or her duties to the Company by withholding confidential information from the Company if to disclose it would result in a breach of any other duty or obligation of confidence owed by him or her

## **20. Directors' power to authorise a conflict of interest**

20.1. The Directors have power to authorise a Director to be in a position of Conflict of Interest provided

20.1.1. in relation to the decision to authorise a Conflict of Interest, the conflicted Director must comply with Article 19 3,

20.1.2. in authorising a Conflict of Interest, the Directors can decide the manner in which the Conflict of Interest may be dealt with and, for the avoidance of doubt, they can decide that the Director with a Conflict of Interest can participate in a vote on the matter and can be counted in the quorum,

20.1.3. the decision to authorise a Conflict of Interest can impose such terms as the Directors think fit and is subject always to their right to vary or terminate the authorisation

- 20.2.** If a matter, or office, employment or position, has been authorised by the Directors in accordance with Article 20 1 then, even if he or she has been authorised to remain at the meeting by the other Directors, the Director may absent himself or herself from meetings of the Directors at which anything relating to that matter, or that office, employment or position, will or may be discussed
- 20.3.** A Director shall not be accountable to the Company for any benefit which he or she derives from any matter, or from any office, employment or position, which has been authorised by the Directors in accordance with Article 20 1 (subject to any limits or conditions to which such approval was subject)

**21. Register of Directors' interests**

The Directors shall cause a register of Directors' interests to be kept. A Director must declare the nature and extent of any interest, direct or indirect, which he or she has in a proposed transaction or arrangement with the Company or in any transaction or arrangement entered into by the Company which has not previously been declared

**APPOINTMENT AND RETIREMENT OF DIRECTORS<sup>xv</sup>**

**22. Methods of appointing Directors**

- 22 1** Those persons notified to the Registrar of Companies as the first Directors of the Company shall be the first Directors.
- 22 2** Any person who is willing to act as a Director, and is permitted by law to do so, may be appointed to be a Director by a decision of the Directors

**23. Termination of Director's appointment<sup>xvi</sup>**

A person ceases to be a Director as soon as

- (a) that person ceases to be a Director by virtue of any provision of the Companies Act 2006, or is prohibited from being a Director by law,
- (b) a bankruptcy order is made against that person, or an order is made against that person in individual insolvency proceedings in a jurisdiction other than England and Wales or Northern Ireland which have an effect similar to that of bankruptcy,
- (c) a composition is made with that person's creditors generally in satisfaction of that person's debts,
- (d) notification is received by the Company from the Director that the Director is resigning from office, and such resignation has taken effect in accordance with its terms (but only if at least two Directors will remain in office when such resignation has taken effect), or
- (e) the Director fails to attend three consecutive meetings of the Directors and the Directors resolve that the Director be removed for this reason
- (f) the Director ceases to be a member



**24. Directors' remuneration<sup>xxx</sup>**

24 1 Directors may undertake any services for the Company that the Directors decide

24 2 Directors are entitled to such remuneration as the Directors determine

(a) for their services to the Company as Directors, and

(b) for any other service which they undertake for the Company

24 3. Subject to the Articles, a Director's remuneration may

(a) take any form, and

(b) include any arrangements in connection with the payment of a pension, allowance or gratuity, or any death, sickness or disability benefits, to or in respect of that director

24 4 Unless the Directors decide otherwise, Directors' remuneration accrues from day to day

24 5 Unless the Directors decide otherwise, Directors are not accountable to the Company for any remuneration which they receive as Directors or other officers or employees of the Company's subsidiaries or of any other body corporate in which the Company is interested

**25. Directors' expenses**

25 1 The Company may pay any reasonable expenses which the Directors properly incur in connection with their attendance at

(a) meetings of Directors or committees of Directors,

(b) general meetings, or

(c) separate meetings of any class of members or of the holders of any debentures of the Company,

or otherwise in connection with the exercise of their powers and the discharge of their responsibilities in relation to the Company

**26. Becoming a member<sup>xx</sup>**

- 29 3 A members' resolution under the Companies Acts removing a Director or an auditor before the expiration of his or her term of office may not be passed as a written resolution
- 29 4 A copy of the written resolution must be sent to every member together with a statement informing the member how to signify their agreement to the resolution and the date by which the resolution must be passed if it is not to lapse Communications in relation to written notices shall be sent to the Company's auditors in accordance with the Companies Acts
- 29 5 A member signifies their agreement to a proposed written resolution when the Company receives from him or her an authenticated Document identifying the resolution to which it relates and indicating his or her agreement to the resolution

- 29 7 A proposed written resolution lapses if it is not passed within 28 days beginning with the circulation date

### **30. Means of communication to be used**

- 30 1 Subject to the Articles, anything sent or supplied by or to the Company under the Articles may be sent or supplied in any way in which the Companies Act 2006 provides for Documents or information which are authorised or required by any provision of that Act to be sent or supplied by or to the Company

**32. Minutes**

32 1 The Directors must cause minutes to be made in books kept for the purpose

32 1 2 of all resolutions of the Company and of the Directors (including, without limitation, decisions of the Directors made without a meeting), and

- (a) any liability incurred by that Director in connection with any negligence, default, breach of duty or breach of trust in relation to the Company or an associated company,
- (b) any liability incurred by that Director in connection with the activities of the Company or an associated company in its capacity as a trustee of an occupational pension scheme (as defined in section 235(6) of the Companies Act 2006), and
- (c) any other liability incurred by that Director as an officer of the Company or an associated company

34 2 This Article does not authorise any indemnity which would be prohibited or rendered void by any provision of the Companies Acts or by any other provision of law

34 3 In this Article

- (a) companies are associated if one is a subsidiary of the other or both are subsidiaries of the same body corporate, and
- (b) a “relevant Director” means any Director or former Director of the Company or an associated company

### **35. Insurance**

35 1 The Directors may decide to purchase and maintain insurance, at the expense of the Company, for the benefit of any relevant Director in respect of any relevant loss

<b>1.13. “Document”</b>	includes, unless otherwise indicated, any document sent or supplied in Electronic Form,
<b>1.14. “Electronic Form” and “Electronic Means”</b>	have the meanings respectively given to them in Section 1168 of the Companies Act 2006,
<b>1.15. “Hard Copy Form”</b>	has the meaning given to it in the Companies Act 2006,
<b>1.16. “Memorandum”</b>	the Company’s memorandum of association,
<b>1.17. “participate”</b>	in relation to a Directors’ meeting, has the meaning given in Article 14,
<b>1.18. “Permitted Industrial and Provident Society”</b>	an industrial and provident society which has a restriction on the use of its assets in accordance with Regulation 4 of the Community Benefit Societies (Restriction on Use of Assets) Regulations 2006 or Regulation 4 of the Community Benefit Societies (Restriction on Use of Assets) Regulations (Northern Ireland) 2006,

The aim of this programme is to create a diverse talent pool equipped with the kinds of leadership capabilities and values the world needs

The City Leadership Programme is a year-long programme built around a two week intensive development programme and 10 months of mentoring by local leaders from the worlds of business, politics and the public sector. An alumni network of participants and contributors will form a source of ongoing support

The curriculum takes students on a journey of personal development, envisioning, life planning, academic enrichment, skills building, exposure and networking. The students develop the emotional and technical tools they need to move from good to great. The emphasis on personal development is a key feature. The challenges they and we will face in the future require more than personal success. We must invest in the kinds of leaders the world needs: emotionally intelligent, engaged, knowledgeable and authentic.

The City Leadership Programme identifies and invests in the lives of high ability, high aspiration young people from challenging backgrounds. They will have experienced socio-economic disadvantage, had significant life challenges or come from groups underrepresented in local, national and international leadership.

It is our belief that left to their own devices these talented young people would do well. But to leave them to their own devices is to underserve them. Why?

The Social Mobility and Child Poverty Commission's 2014 Report "Elitest Britain?" argues

*"In Britain today, fairness and meritocracy are core values but the evidence suggests we are a long way from a society where everyone has an equal chance"*

*"There appears to be a stronger relationship between parental background and children's future income in Britain than in many other countries"*

*"Our examination of who gets the top jobs in Britain today found elitism so stark that it could be called 'Social Engineering'. The sheer scale of the dominance of certain backgrounds raises questions about the degree to which the make-up of the elite reflects merit"*

We can draw from this that to the extent that those born into socio-economic advantage and the existing elite are systematically engineered into opportunity, those born into disadvantage and born outside of the elite are systematically engineered out of opportunity. Whatever the forces at play, this is at the heart of the UK's social immobility.

The exceptional young people we target have the talent to perform at the highest levels in the careers they pursue. But they are born into classes and contexts that engineer them out of the opportunities to realise their full potential. The City Leadership Programme is the intentional intervention these young people need. It will equip them with the skills, tools and connections that will help them overcome these barriers of social immobility.

At the heart of the City Leadership Programme model is a partnership between business and higher education. A supportive business community and supportive university are two of the criteria we look for before accepting an invitation to work in a city. 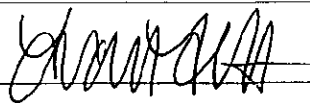

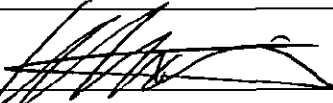

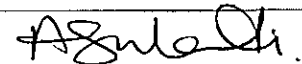
