Directors' report for the year ended 30 June 2019

The directors present their report and the audited financial statements of the company for the year ended 30 June 2019.

Principal activities

The company is the parent of a group of which the principal activities are that of construction and operation of Reserve Power plants.

Going concern

The company holds an investment in Clyne Power Limited. As part of Clyne Power Limited's ongoing review of going concern by Clyne Power Limited's Directors, they have reviewed its position in detail, including the impact of the recent outbreak of COVID-19 on its performance and cash flows. The Directors have prepared cash flow forecasts, taking into account data available for the wider energy market.

Clyne Power Limited is funded by external debt facility which includes financial performance based covenants. The forecasts show that whilst covenants are expected to be met in the twelve months from signing these accounts, there is limited headroom on the covenants. Clyne Power Limited's Directors have not been able to obtain Reserve Power specific forecasts for COVID-19 and therefore sensitivity analysis using Reserve Power specific forecasts for COVID-19 has not been performed. If due to a period of significantly reduced demand for energy or significantly reduced energy prices actual results are lower than forecasts, this could result in Clyne Power Limited breaching its covenants. Based on previous experience Clyne Power Limited's Directors have a reasonable expectation that any covenant breaches will be waived by Clyne Power Limited's lender.

No written confirmation, confirming Clyne Power Limited's lender's intention to provide covenant waivers in the event of a breach has been provided by Clyne Power Limited's lender. Therefore whilst Clyne Power Limited's Directors believe that any covenant breaches would be waived, there can be no assurance that they will be able to do so on terms acceptable to the subsidiary, on a timely basis or at all. As a result of which the amounts due to the lender by Clyne Power Limited may be payable within one year. This could impact Clyne Power Limited's ability to continue as a going concern and indicates the existence of a material uncertainty which may cast significant doubt on Clyne Power Limited's ability to continue as a going concern. Given the significant investment held in Clyne Power Limited, this could impact the company's ability to continue as a going concern and indicates the existence of a material uncertainty which may cast significant doubt on the company's ability to continue as a going concern. The financial statements do not include the adjustments that would result if the company was unable to continue as a going concern.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006.

Prior year restatement

As at 1 July 2017, which is the beginning of the earliest prior period presented, the amounts for Debtors: amounts falling due after one year was understated by £690,754 and the amount for Debtors: amounts falling due within one year, was overstated by £690,754. The prior year figure as at 30 June 2018 for Prepayments and accrued income, relating to accrued interest on unsecured loan amounts owed by group undertakings, of £1,094,252 has been reclassified to Amounts owed by group undertakings within Debtors: amounts falling due after one year. These amounts are repayable at the final repayment date, which is after more than 12 months and were classified incorrectly in prior years. This restatement has reduced the Debtors: amounts falling due within one year balance by £1,094,252 to £0 and increased the Debtors: amounts falling due after one year balance by £1,094,252 to £5,840,561. There is no impact of this restatement on profit or loss or equity.

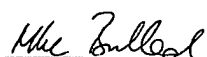

Report on the audit of the financial statements

Opinion

In our opinion, Catria Limited's financial statements:

- give a true and fair view of the state of the company's affairs as at 30 June 2019 and of its loss for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards, comprising FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, and applicable law); and
- have been prepared in accordance with the requirements of the Companies Act 2006.

We have audited the financial statements, included within the Directors' report and financial statements (the "Annual Report"), which comprise: the Balance sheet as at 30 June 2019 and the Statement of income and retained earnings for the year then ended; and the notes to the financial statements, which include a description of the significant accounting policies.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities under ISAs (UK) are further described in the Auditors' responsibilities for the audit of the financial statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

Material uncertainty related to going concern

In forming our opinion on the financial statements, which is not modified, we have considered the adequacy of the disclosure made in note 2.4 to the financial statements concerning the company's ability to continue as a going concern. The company holds a significant investment in Clyne Power Limited. A severe but plausible downside involving a period of significantly reduced demand for energy or significantly reduced energy prices could result in Clyne Power Limited breaching its covenants. Whilst Clyne Power Limited's Directors believe that any covenant breaches would be waived, there is currently no assurance that any covenant waivers can be obtained and this could have a significant impact on the company's position as the parent entity. These conditions, along with the other matters explained in note 2.4 to the financial statements, indicate the existence of a material uncertainty which may cast significant doubt about the company's ability to continue as a going concern. The financial statements do not include the adjustments that would result if the company was unable to continue as a going concern.

Reporting on other information

The other information comprises all of the information in the Annual Report other than the financial statements and our auditors' report thereon. The directors are responsible for the other information. 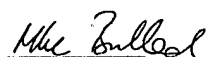

1. General information

Catria Limited is a private company, limited by shares, incorporated in and domiciled in England, the United Kingdom, registered number 09493118. The registered office is 6th Floor, 33 Holborn, London, EC1N 2HT.

The company is the parent of a group of which the principal activities are that of construction and operation of Reserve Power plants.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements are prepared on the going concern basis, under the historical cost convention and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The areas involving a higher degree of judgement complexity, or areas where assumptions and estimates are significant to the financial statements are disclosed in note 3.

The following principal accounting policies have been applied:

2.2 Exemptions for qualifying under FRS 102

FRS 102 allows a qualifying entity certain disclosure exemptions, subject to certain conditions, which have been complied with, including notification of, and no objection to, the use of exemptions by the company's shareholders.

The company has taken advantage of the following exemptions:

- from preparing a statement of cash flows, required under Section 7 of FRS 102 and para 3.17(d), on the basis that it is a small company;
- from disclosing the company's key management personnel compensation as required by FRS 102 para 33.7; and
- from disclosing related party transactions that are wholly owned within the same group.

2.3 Consolidation

The company is the parent undertaking of a small group and as such is not required by the Companies Act 2006 to prepare group financial statements. These financial statements therefore present information about the company as an individual undertaking and not about its group.

2.5 Interest income

Interest income is recognised using the effective interest rate method.

2.6 Investments

Investments held as fixed assets are shown at cost less provision for impairment.

2.7 Impairment of non-financial assets

At each reporting date non-financial assets not carried at fair value are assessed to determine whether there is an indication that the asset (or asset's cash generating unit) may be impaired. If there is such an indication the recoverable amount of the asset (or asset's cash generating unit) is compared to the carrying amount of the asset (or asset's cash generating unit).

The recoverable amount of the asset (or asset's cash generating unit) is the higher of the fair value less costs to sell and value in use. Value in use is defined as the present value of the future cash flows before interest and tax obtainable as a result of the asset's (or asset's cash generating unit) continued use. These cash flows are discounted using a pre-tax discount rate that represents the current market risk-free rate and the risks inherent in the asset.

2.7 Impairment of non-financial assets (continued)

If the recoverable amount of the asset (or asset's cash generating unit) is estimated to be lower than the carrying amount, the carrying amount is reduced to its recoverable amount. An impairment loss is recognised in the statement of income and retained earnings, unless the asset has been revalued when the amount is recognised in other comprehensive income to the extent of any previously recognised revaluation. Thereafter any excess is recognised in the statement of income and retained earnings.

If an impairment loss is subsequently reversed, the carrying amount of the asset (or asset's cash generating unit) is increased to the revised estimate of its recoverable amount, but only to the extent that the revised carrying amount does not exceed the carrying amount that would have been determined (net of depreciation or amortisation) had no impairment loss been recognised in prior periods. A reversal of an impairment loss is recognised in the statement of income and retained earnings.

2.8 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

2.9 Taxation

Taxation expense for the period comprises current and deferred tax recognised in the reporting period. Tax is recognised in the statement of income and retained earnings, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case tax is also recognised in other comprehensive income or directly in equity respectively.

Current or deferred taxation assets and liabilities are not discounted.

(i) Current tax

Current tax is the amount of income tax payable in respect of the taxable profit for the period or prior periods. Tax is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the period end.

(ii) Deferred tax

Deferred tax arises from timing differences that are differences between taxable profits and total comprehensive income as stated in the financial statements. These timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in the financial statements.

Deferred tax is recognised on all timing differences at the reporting date. Unrelieved tax losses and other deferred tax assets are only recognised when it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the period end and that are expected to apply to the reversal of the timing difference.

2.10 Financial assets

Basic financial assets, including trade and other receivables, cash and bank balances and investments in commercial paper, are initially recognised at transaction price, unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest.

Such assets are subsequently carried at amortised cost using the effective interest method.

At the end of each reporting period financial assets measured at amortised cost are assessed for objective evidence of impairment. If an asset is impaired the impairment loss is the difference between the carrying amount and the present value of the estimated cash flows discounted at the asset's original effective interest rate. The impairment loss is recognised in the statement of income and retained earnings.

If there is decrease in the impairment loss arising from an event occurring after the impairment was recognised the impairment is reversed. The reversal is such that the current carrying amount does not exceed what the carrying amount would have been had the impairment not previously been recognised. The impairment reversal is recognised in the statement or income and retained earnings.

Financial assets are derecognised when (a) the contractual rights to the cash flows from the asset expire or are settled, or (b) substantially all the risks and rewards of the ownership of the asset are transferred to another party or (c) control of the asset has been transferred to another party who has the practical ability to unilaterally sell the asset to an unrelated third party without imposing additional restrictions.

2.11 Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Where the contractual obligations of financial instruments (including share capital) are equivalent to a similar debt instrument, those financial instruments are classed as financial liabilities. Financial liabilities are presented as such on the balance sheet. Finance costs and gains or losses relating to financial liabilities are included in the statement of income and retained earnings.

Where the contractual terms of share capital do not have any terms meeting the definition of a financial liability this is classed as an equity instrument. Dividends and distributions relating to equity instruments are debited direct to equity.

3. Critical accounting judgements and estimation uncertainty

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

(a) Critical judgements in applying the entity's accounting policies

The company has not made any critical judgements in applying the entity's accounting policies.

(b) Critical accounting estimates and assumptions

(i) Impairment of intercompany loan receivables

The company makes an estimate of the recoverable value of amounts owed by group undertakings.

The recoverable amount of the asset (or asset's cash generating unit) is the higher of the fair value less costs to sell and value in use. Value in use is defined as the present value of the future cash flows before interest and tax obtainable as a result of the asset's (or asset's cash generating unit) continued use. These cash flows are discounted using a pre-tax discount rate that represents the current market risk-free rate and the risks inherent in the asset.

If the recoverable amount of the asset (or asset's cash generating unit) is estimated to be lower than the carrying amount, the carrying amount is reduced to its recoverable amount. An impairment loss is recognised in the statement of income and retained earnings.

If an impairment loss is subsequently reversed, the carrying amount of the asset (or asset's cash generating unit) is increased to the revised estimate of its recoverable amount, but only to the extent that the revised carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised in prior periods. A reversal of an impairment loss is recognised in the statement of income and retained earnings.

See note 6 for the net carrying amount of the debtors and associated impairment provision.

The recoverable amounts have been determined based on value-in-use calculations. These calculations require the use of key assumptions such as forecasts of future energy prices, demand, discount rates and long term growth rates. An impairment charge of £3,090,992 arose during the course of the 2019 year, resulting in the carrying amount of the CGU being written down to its recoverable amount of £1,655,317.

The financial statements do not include the adjustments that would result if the company was unable to continue as a going concern.

The directors do not consider the company to have an ultimate controlling party or ultimate parent company, by virtue of a split holding in its shares.
