Central A1 Limited & 1,795 other companies (together 'the Companies') - All in Creditors' Voluntary Liquidation

We are now in a position to conclude these Liquidations and below is our final, consolidated report as required by Section 106(1) of the Insolvency Act 1986 and Rule 18.14 of the Insolvency (England and Wales) Rules 2016 (hereafter 'the Rules'). This report covers the period from 5 October 2019 to 26 February 2020 ('the Final Period') and it should be read in conjunction with previous reports circulated to creditors.

The Companies' affairs are fully wound up and unless any substantive issues are raised by creditors no further report will be issued and this report will be presented as the final report in each of the Liquidations.

We can confirm that notice of no further dividend is enclosed at Appendix 4, as required by Rule 14.36 of the Rules.

Statutory Information regarding the Joint Liquidators

The Joint Liquidators are Malcolm Cohen (officeholder number: 6825) and Shane Crooks (officeholder number: 15110), both of BDO LLP, 55 Baker Street, London, W1U 7EU. The Joint Liquidators were appointed on 5 October 2016 and carry out their functions jointly and severally meaning any action can be done by one Joint Liquidator or by both of them.

Please note that the Joint Liquidators are appointed over 1,796 separate companies, details of which can be found on the schedule enclosed at Appendix 7. Given the close relationship between the Companies and the similarities in their affairs, we are issuing one, consolidated report for all of the Companies, which includes a consolidated receipts and payments account for the Final Period.

BDO LLP, a UK limited liability partnership registered in England and Wales under number OC305127, is a member of BDO International Limited, a UK company limited by guarantee, and forms part of the international BDO network of independent member firms. A list of members' names is open to inspection at our registered office, 55 Baker Street, London W1U 7EU. BDO LLP is authorised and regulated by the Financial Conduct Authority to conduct investment business.

The Joint Liquidators are Data Controllers as defined by the General Data Protection Regulations. BDO LLP will act as Data Processor on the instruction of the Data Controllers. Personal data will be kept secure and processed only for matters relating to the Liquidation of the Companies. The Joint Liquidators consider that reporting on a consolidated basis maximises efficiencies and reduces the costs of reporting to the Liquidation estates (which have common creditors).

Our annual report dated 4 December 2017 set out in detail the background to the Companies and the events leading up to their Liquidation, therefore we do not propose to repeat that information in this report.

Events following the Joint Liquidators' appointment

As discussed in previous reports, shortly after the Joint Liquidators' appointment, the former liquidator, Paul Appleton of David Rubin & Partners Limited ('DRP'), requested that DRP's outstanding reporting accountant fees be paid as an expense of the Liquidations. DRP advised that the balance of the Companies' cash (c£2.88m) had been transferred into DRP's client account prior to the commencement of the Liquidations.

On 28 October 2016, DRP commenced a Court application, to which the Joint Liquidators were named as Respondents, seeking various orders and declarations to the effect that the reporting accountant fee sought by DRP should be immediately paid as a reasonable and necessary expense of the Liquidations. The Joint Liquidators defended this application, which resulted in protracted litigation and a three-day trial set to commence on 13 June 2017.

Shortly before the commencement of the trial, and following discussions between DRP and the Joint Liquidators, the application was settled between the parties. The terms of the settlement are confidential and cannot be disclosed by the Joint Liquidators, although we are able to advise that, as noted on the attached consolidated summary of our receipts and payments, a payment of c£2.122m was made to DRP in full and final settlement of DRP's reporting accountant fee (inclusive of VAT which has since been reclaimed by the Joint Liquidators).

This left a cash balance of c£767k (plus the VAT which has been reclaimed) across the liquidation estates.

Receipt and Payments

We enclose at Appendix 1, for your information, a consolidated summary of our receipts and payments for the Final Period, showing a nil balance in hand. We can confirm that this account has been reconciled. I comment specifically on certain items elsewhere in this report, otherwise I consider that this summary is self-explanatory.

Restoration of Dissolved Companies

As previously reported, subsequent to the appointment of the Joint Liquidators, 92 of the Companies ('the Dissolved Companies') were struck off the Register and dissolved by Companies House, due to delays in the processing of documents by Companies House confirming the appointment of the Joint Liquidators.

Following an application to the County Court for Orders that the Dissolved Companies be restored to the Register, these Orders were sealed on 8 May 2018 and the Dissolved Companies have since been restored to the Register. They are now correctly recognised as being in Creditors' Voluntary Liquidation following the re-filing of the necessary documentation.

Investigations

The Joint Liquidators have a duty to investigate the affairs of the Companies and also the conduct of the directors and, in respect of the latter, to submit a confidential statutory report to the Secretary of State. We can confirm that such a report has been submitted.

In addition, we have carried out further investigations into the affairs of the Companies and the circumstances of their failure, to establish whether there are any other potential assets that could be realised for the benefit of the Companies' creditors. These investigations have included meeting with the director of the firm of accountants which previously provided services to the Companies, to discuss its role in the operations of the Companies, along with other stakeholders who might have been able to provide relevant information.

Our investigations have now concluded and, as such, we are now taking steps to close the Liquidations.

Progress of the Liquidation

No further assets remain to be realised. Now that all outstanding statutory matters are finalised, it is the intention of the Joint Liquidators to conclude the Liquidations and move the Companies to dissolution.

We can confirm that there are no assets of a peculiar or special nature which cannot be sold. Consequently there has been no distribution of unsold assets to creditors, as mentioned in Rules 18.10/14.13 of the Insolvency (England & Wales) Rules 2016.

Outcome for creditors

There are no secured creditors registered in respect of the Companies.

The Companies had no employees at the date of appointment and consequently there were no preferential claims.

The statements of affairs prepared for each of the Companies stated that there were three creditors with aggregate unsecured claims totalling £4,271,322. Unsecured claims of £47,215,347 were received in the Liquidations, predominantly consisting of HMRC's final claim of £46,832,347 across the Companies. Of this claim, the sum of £339,382 was rejected as it related to companies outside of the Group. All other claims were admitted in full.

As has been previously reported, the Joint Liquidators made provisions to allow for a 15% 'carve-out', which was specifically reserved from net realisations in the Companies' estates, to be made available for the benefit of creditors with agreed claims.

On 31 May 2019, the Joint Liquidators paid a first and final dividend in all of the Liquidations, which equated to an effective rate across the Liquidations of 0.463p in the £.

Prescribed Part

Under Section 176A of the Insolvency Act 1986 where, after 15 September 2003, a company has granted a floating charge to a secured creditor, a proportion of the net property of the company must be made available purely for the unsecured creditors. The Companies have not granted

floating charges to any creditor after 15 September 2003 and consequently there has been no prescribed part in these Liquidations.

Joint Liquidators' Remuneration

Pursuant to the Rules, the Joint Liquidators are obliged to fix their remuneration in accordance with Rule 18.16. This permits remuneration to be fixed either:

- (1) as a percentage of the assets realised and distributed; and/or
- (2) by reference to the time the Joint Liquidators and their staff have spent attending to matters in the liquidation; and/or
- (3) as a set amount; and/or
- (4) as a combination of the above.

The Joint Liquidators' remuneration in respect of 1,704 of the Companies (being all of the Companies with the exception of the Dissolved Companies) was approved on a fixed set amount as detailed in the appendices to our report dated 4 December 2017. These fees were approved by the majority of creditors and totalled c£411k. An additional fee approval of c£131k was sought in our report dated 20 November 2018 in respect of the Liquidations of the Dissolved Companies and subsequently approved. A final tranche of remuneration in the sum of £12,304 across all of the Liquidations was agreed by way of a decision process which was effective on 29 October 2019.

To date, the Joint Liquidators have drawn £554k on account of their remuneration, as shown on the enclosed consolidated summary of the Joint Liquidators' receipts and payments. During the Final Period the balance of the Joint Liquidators' remuneration as approved by creditors, in the sum of £26,054.78, was drawn from the Liquidation estates, as shown on the account of the Joint Liquidators' receipts and payments.

We enclose at Appendix 2 two schedules detailing the time costs incurred by the Joint Liquidators and their staff to date. The first schedule covers the Final Period and records time costs of £22,595, which represents 94 hours spent at an average charge out rate of £241 per hour. The second schedule covers the whole period of appointment and records time costs of £807,364, which represents 2,201 hours spent at an average charge out rate of £367 per hour.

Creditors will therefore note that the total fixed fee as proposed by the Joint Liquidators resulted in a better outcome for the Liquidation estates and the Companies' creditors than would have been the case if fees were agreed on a time costs basis. The Joint Liquidators do not propose to recover their times costs in full, and will therefore be required to write off the balance of their total time costs at the conclusion of the Liquidations.

For guidance, we enclose at Appendix 3 a document that outlines the policy of BDO LLP in respect of fees and disbursements.

Joint Liquidators' Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. No category 1 disbursements have accrued during the Final Period.

Some Liquidators recharge expenses for example, postage, stationary, photocopying charges, telephone and fax costs, which cannot economically be recorded in respect of each specific case. Such expenses, which are apportioned to cases, require the approval of the creditors before they can be drawn, and these are known as category 2 disbursements. The policy of BDO LLP in respect of this appointment was not to charge any category 2 disbursements.

Total disbursements of £18,142 have been incurred in the Liquidations as detailed below, all of which have been drawn.

Creditors' rights and enquiries

Creditors with the concurrence of at least 5% in value of the unsecured creditors may, within 21 days of this report, request in writing further information regarding the remuneration and expenses set out in this report. In accordance with Rule 18.9(3) of the Rules, within 14 days of a request we will provide further information or explain why further information is not being provided. Creditors may access information setting out their rights in respect of the approval of a liquidator's remuneration at <https://www.r3.org.uk/what-we-do/publications/professional/fees>.

A creditor (who need not be the creditor who asked for the information) may, with the concurrence of at least 5% or more in value of the creditors (including the creditor in question), apply to the court within 21 days of the Joint Liquidators' response or the expiry for the period of any response and the court may make such order as it thinks fit (Rule 18.9(6) and (7) of the Rules).

Creditors with the concurrence of at least 10% of the creditors may apply to the court if they consider that the remuneration of the Joint Liquidators, or the basis fixed for their remuneration or expenses charged by them are excessive (Rule 18.34 of the Rules). Such an application must be made within 8 weeks of receiving this draft report. The text of Rules 18.9 and 18.34 are set out at the end of this report.

Release of the Joint Liquidators

The Joint Liquidators will be released from office under section 173 of the Insolvency Act 1986 at the same time as vacating office, unless any creditor objects. A creditor who wishes to object to the release must deliver a notice in writing to the Joint Liquidators within eight weeks of this report or, if creditors raise other matters under Rules 18.9 or 18.34 as mentioned above, when those matters are finally determined by the court.

Appendix 3

In accordance with best practice we provide below details of policies of BDO LLP in respect of fees and expenses for work in relation to the above liquidations.

This in no way implies that staff at all such grades will work on the case. The rates charged by BDO LL are reviewed on a regular basis and are adjusted to take account of inflation and the firm's overheads.

Time spent on casework is recorded directly to the relevant case using a computerised time recording system and the nature of the work undertaken is recorded at that time. Units of time can be as small as 3 minutes. BDO LLP records work in respect of insolvency work under the following categories:

- Pre Appointment
- Steps upon Appointment
- Planning and Strategy
- General Administration
- Asset Realisation/Management
- Trading Related Matters
- Employee Matters
- Creditor Claims
- Reporting
- Distribution and Closure
- Other Issues

Under each of the above categories the work is recorded in greater detail in sub categories. Please note that the 11 categories above provide greater detail than the six categories recommended by the Recognised Professional Bodies who are responsible for licensing and monitoring insolvency practitioners.

Where an officeholder's remuneration is approved on a time cost basis the time invoiced to the case will be subject to VAT at the prevailing rate.

Where remuneration has been approved on a time costs basis a periodic report will be provided to any committee appointed by the creditors or, in the absence of a committee, to the creditors. The report will provide a breakdown of the remuneration drawn and will enable the recipients to see the average rates of such costs.



Other Costs

Where expenses are incurred in respect of the insolvent estate they will be recharged. Such expenses can be divided into two categories.

1) Category 1

This heading covers expenses where BDO LLP has met a specific cost in respect of the insolvent estate where payment has been made to a third party. Such expenses may include items such as advertising, couriers, travel (by public transport), land registry searches, fees in respect of swearing legal documents etc. In each case the recharge will be reimbursement of a specific expense incurred.

2) Category 2

Insolvency practice additionally provides for the recharge of expenses such as printing, stationery, photocopying charges, telephone, email and other electronic communications e.g. webhosting, which cannot be economically recorded in respect of each specific case. Such expenses, which are apportioned to cases, must be approved by the creditors in accordance with the Insolvency (England and Wales) Rules 2016 before they can be drawn, and these are known as category 2 disbursements.

A further disbursement under this heading is the cost of travel where staff use either their own vehicles or company cars in travelling connected with the insolvency. In these cases a charge of 45p per mile is raised which is in line with the HM Revenue & Customs' Approved Mileage Rates (median - less than 10,000 miles per annum) which is the amount the firm pays to staff. Where costs are incurred in respect of mileage, approval is required in accordance with the Insolvency (England and Wales) Rules 2016 to recover this disbursement.

The policy of BDO LLP in respect of these particular appointments is not to charge any expense which is not a specific costs to the case, therefore there will be no category 2 disbursements charged.

Where applicable, all disbursements will be subject to VAT at the prevailing rate.

Appendix 6**Statement from the Insolvency (England and Wales) Rules 2016 regarding the rights of creditors in respect of the Joint Liquidators' fees and expenses:****Creditors' and members' requests for further information in administration, winding up and bankruptcy**

18.9.—(1) The following may make a written request to the office-holder for further information about remuneration or expenses (other than pre-administration costs in an administration) set out in a progress report under rule 18.4(1)(b), (c) or (d) or a final report under rule 18.14—

- (a) a secured creditor;
 - (b) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question);
 - (c) members of the company in a members' voluntary winding up with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company;
 - (d) any unsecured creditor with the permission of the court; or
 - (e) any member of the company in a members' voluntary winding up with the permission of the court.
- (2) A request, or an application to the court for permission, by such a person or persons must be made or filed with the court (as applicable) within 21 days of receipt of the report by the person, or by the last of them in the case of an application by more than one member or creditor.
- (3) The office-holder must, within 14 days of receipt of such a request respond to the person or persons who requested the information by—
- (a) providing all of the information requested;
 - (b) providing some of the information requested; or
 - (c) declining to provide the information requested.
- (4) The office-holder may respond by providing only some of the information requested or decline to provide the information if—
- (a) the time or cost of preparation of the information would be excessive; or
 - (b) disclosure of the information would be prejudicial to the conduct of the proceedings;
 - (c) disclosure of the information might reasonably be expected to lead to violence against any person; or
 - (d) the office-holder is subject to an obligation of confidentiality in relation to the information.
- (5) An office-holder who does not provide all the information or declines to provide the information must inform the person or persons who requested the information of the reasons for so doing.
- (6) A creditor, and a member of the company in a members' voluntary winding up, who need not be the same as the creditor or members who requested the information, may apply to the court within 21 days of—
- (a) the office-holder giving reasons for not providing all of the information requested; or
 - (b) the expiry of the 14 days within which an office-holder must respond to a request.
- (7) The court may make such order as it thinks just on an application under paragraph (6).

Remuneration and expenses: application to court by a creditor or member on grounds that remuneration or expenses are excessive

18.34.—(1) This rule applies to an application in an administration, a winding-up or a bankruptcy made by a person mentioned in paragraph (2) on the grounds that—

- (a) the remuneration charged by the office-holder is in all the circumstances excessive;
 - (b) the basis fixed for the office-holder's remuneration under rules 18.16, 18.18, 18.19, 18.20 and 18.21 (as applicable) is inappropriate; or
 - (c) the expenses incurred by the office-holder are in all the circumstances excessive.
- (2) The following may make such an application for one or more of the orders set out in rule 18.36 or 18.37 as applicable—
- (a) a secured creditor,
 - (b) an unsecured creditor with either—
 - (i) the concurrence of at least 10% in value of the unsecured creditors (including that creditor), or
 - (ii) the permission of the court, or
 - (c) in a members' voluntary winding up—

- (i) members of the company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company, or
- (ii) a member of the company with the permission of the court.
- (3) The application by a creditor or member must be made no later than eight weeks after receipt by the applicant of the progress report under rule 18.3, or final report or account under rule 18.14 which first reports the changing of the remuneration or the incurring of the expenses in question ("the relevant report").

Applications under rules 18.34 and 18.35 where the court has given permission for the application

18.36. –(1) This rule applies to applications made with permission under rules 18.34 and 18.35.

- (2) Where the court has given permission, it must fix a venue for the application to be heard.
- (3) The applicant must, at least 14 days before the hearing, deliver to the office-holder a notice stating the venue and accompanied by a copy of the application and of any evidence on which the applicant intends to rely.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders--
 - (a) an order reducing the amount of remuneration which the office-holder is entitled to charge;
 - (b) an order reducing any fixed rate or amount;
 - (c) an order changing the basis of remuneration;
 - (d) an order that some or all of the remuneration or expenses in question is not to be treated as expenses of the administration, winding up or bankruptcy;
 - (e) an order for the payment of the amount of the excess of remuneration or expenses or such part of the excess as the court may specify by --
 - (i) the administrator or liquidator or the administrator's or liquidator's personal representative to the company, or
 - (ii) the trustee or the trustee's personal representative to such person as the court may specify as property comprised in the bankrupt's estate;
 - (f) any other order that it thinks just.
- (5) An order under paragraph (4)(b) or (c) may only be made in respect of periods after the period covered by the relevant report.
- (6) Unless the court orders otherwise the costs of the application must be paid by the applicant, and are not payable as an expense of the administration, winding up or bankruptcy.

Applications under rule 18.34 where the court's permission is not required for the application

18.37. –(1) On receipt of an application under rule 18.34 for which the court's permission is not required, the court may, if it is satisfied that no sufficient cause is shown for the application, dismiss it without giving notice to any party other than the applicant.

- (2) Unless the application is dismissed, the court must fix a venue for it to be heard.
- (3) The applicant must, at least 14 days before any hearing, deliver to the office-holder a notice stating the venue with a copy of the application and of any evidence on which the applicant intends to rely.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders--
 - (a) an order reducing the amount of remuneration which the office-holder is entitled to charge;
 - (b) an order reducing any fixed rate or amount;
 - (c) an order changing the basis of remuneration;
 - (d) an order that some or all of the remuneration or expenses in question be treated as not being expenses of the administration or winding up or bankruptcy;
 - (e) an order for the payment of the amount of the excess of remuneration or expenses or such part of the excess as the court may specify by --
 - (i) the administrator or liquidator or the administrator's or liquidator's personal representative to the company, or
 - (ii) the trustee or the trustee's personal representative to such person as the court may specify as property comprised in the bankrupt's estate;
 - (f) any other order that it thinks just.
- (5) An order under paragraph (4)(b) or (c) may only be made in respect of periods after the period covered by the relevant report.
- (6) Unless the court orders otherwise the costs of the application must be paid by the applicant, and are not payable as an expense of the administration or as winding up or bankruptcy
