- 1.2 No ethical issues have come to light during the period reported on.

**2 JOINT LIQUIDATORS' ACTIONS SINCE THE LAST REPORT**

- 2.1 This report should be read in conjunction with my receipts and payments account, which is attached as Appendix 1. Please note that the figures are shown net of VAT.
- 2.2 My receipts and payments account confirms that there were no assets in the Company and therefore there have been no realisations.

Other matters

- 2.3 In addition to my responsibility to realise the Company's assets, I am required to comply with various legislative and best practice obligations and deadlines. These obligations include filing of documents with the Registrar of Companies, ensuring that all receipts and payments are promptly dealt with and proper accounting records are maintained. In addition, I am required to undertake periodic case reviews to monitor progress, advise creditors of the liquidation and record any claims received. Furthermore, I am obliged to deal with any other day to day matters that may arise during the liquidation.
- 2.4 I have written to HMRC to request tax clearance, which has been granted by the corporation tax department. However, the MVL team submitted a claim. This was challenged as it included assessments for PAYE returns for periods after the scheme ceased. I then spent significant time liaising with the tax team at Price Bailey to look into the other elements of the claim which were outstanding, and the parent company has agreed to settle those elements of the debt. HMRC resubmitted their claim removing the assessments for periods after the PAYE scheme ceased, however it still included late filing penalties for returns for these periods. A large amount of time has been spent trying to contact HMRC to address this, however they have been unresponsive.

### 3 LIABILITIES

#### Secured liabilities

- 3.1 An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has not granted any debentures.

#### Preferential creditors

- 3.2 The Company did not have any liabilities to this class of creditor at the date of liquidation.

#### Unsecured creditors

- 3.3 As mentioned above, the only claim I have received in the liquidation is the claim from HMRC which will be settled by the parent company. I am still attempting to determine the exact amount of the claim.

### 4 JOINT LIQUIDATORS' REMUNERATION

- 4.1 The joint liquidators' remuneration was approved by the members on 29 September 2020.
- 4.2 This remuneration is to be paid on a fixed fee basis of £10,000.00 plus expenses and VAT. If for reasons outside our control, the liquidation should continue for more than 12 months, there will be an additional charge of £1,000 plus VAT for each anniversary of the liquidation passed.
- 4.3 The sum of £10,000 plus VAT has been paid in the reporting period by the parent company.

### 5 JOINT LIQUIDATORS' EXPENSES

- 5.1 I have incurred expenses in the liquidation of £270 in the period to 28 September 2021. I have not been able to draw any expenses. They will be invoiced to a third party when the liquidation is concluded.
- 5.2 The following expenses have been incurred but have not yet been paid:

## **6 FURTHER INFORMATION**

- 6.1 Within 21 days of receipt of a progress report a member may request that the joint liquidators provide further information about the fees and expenses set out in this report. A request must be in writing, with the concurrence of at least 5% in value of members, or the permission of the court.
- 6.2 Any member, if they consider that the joint liquidators' fees are excessive, or that the basis of those fees is inappropriate or that the expenses incurred are excessive, may make an application to the court if at least 10% in value of the members agree. An application must be made within 8 weeks of receipt of this report.
