A General

The model articles for private companies limited by guarantee contained in the Companies (Model Articles) Regulations 2008 will be the Articles of Association of the Company subject to the modifications and additions which appear below

B. Membership

In this clause "Owner" means a long leasehold owner for the time being of a flat comprising part of Roman Heights 44 Preston Road Weymouth DT3 6PZ

- a. Every Owner will be a Member but where two or more persons are together the owner of a house they will together constitute one member and the vote (where more than one is cast) of the person whose name appears earlier on the Membership Register of the Company will be accepted to the exclusion of any other.
- b. Every Owner will cease to be a Member if he is not an Owner and the Company must on receipt of evidence that a Member is no longer an Owner delete the name of the Member from the Membership Register of the Company.
