For the Year Ended 30 April 2017

The trustees, who are also the directors of the company, are pleased to provide their report for Foodwise (TLC) Limited ("Foodwise") for the year ended 30 April 2017 which represents the second period of activities.

Incorporation

The company was incorporated on 26 April 2015 as a company limited by guarantee and commenced trading immediately.

The company obtained charitable status on 15 December 2015 with registered charity number 1164890.

Objectives and Activities

Foodwise's charitable aim is to relieve financial hardship through the provision of food coaching to teach people how to budget, purchase, prepare and cook nutritional food at reasonable cost. In practical terms, Foodwise runs courses where people are coached by a Food Coach to prepare and cook a variety of dishes over a six week period. The course runs for a few hours, one day per week, normally for six weeks and usually within a school term. A different meal will be cooked on each day, with the aim of increasing the cooking skills and knowledge of the attendees. The menus are available free of charge on the charity's website which may be found at www.foodwisetlc.care.

The courses are entirely free and the charity provides not only the location, equipment and Food Coach but also sufficient food for the participant to feed their immediate family that evening. The primary aim is to teach life skills, whilst providing much needed food for the family. Where a Food Bank will often only provide sufficient food for three main meals within a three month period, Foodwise can triple the assistance provided over a six week period. Participants can attend multiple courses, where space on a course is available.

The trustees have had regard to the Charity Commission's guidance on public benefit and consider that Foodwise's activities provide public benefit through providing vulnerable people with the skills to cook healthy food for themselves and their families within a manageable budget.

In 2017 Foodwise has commenced operations, on a test basis, to feed children within school holiday periods. Foodwise will look to expand these activities in future years by developing closer ties to schools and children's centres.

Achievements and Performance

During the year, FoodWise ran courses at the Lighthouse in Woking, the United Reformed Church in Westborough Guildford, a session for Woking Borough Council at New Life Church in partnership with Christians Against Poverty (CAP) and sessions for the Children's Centre Young Parent Group at the YPOD, Woking. Each course consisted of either five or six sessions.

Most venues have capacity for six to eight participants although the Children's Centre Young Parent group at the YPOD was a group session as part of their regular group meet up and included around 15 people each session.

Whilst some courses have been 100% full others have run at 75% or 50% capacity. Attendance has been up to 93% on one course, but for a couple of courses was disappointingly low at 40% and 61%.

Foodwise seeks to assist a wide range of people from young mothers to people with dependency or addiction issues. Therefore full attendance of courses can be somewhat difficult to achieve, bearing in mind the complexities of the lives and challenges faced by some of the attendees.

The trustees are very pleased with how the courses have been received as illustrated through comments received from participants during the year.

"Before this course I would buy frozen ready meals/pizzas etc." (Westborough Course)

"We weren't just shown a meal, we were told other ways to use the skills/sauces etc. to make other meals". (Westborough Course)

"Coming into this course I was scared of going into the kitchen as I found it extremely daunting. Gracie has not only given me some lovely healthy meals to be able to prepare but a confidence and sense of pride that I am finally able to provide for my daughter. Knowing she will always be welcome in the kitchen with Mummy, [my daughter] will never have to be afraid of the kitchen like I was and this alone has made this course worth its weight in gold." Linda Aston moved to pastures new at the end of December 2016 and was replaced by Ruth Boughton in early March 2017. We are very grateful to Linda for her enthusiasm and determination in developing Foodwise in its early days and wish Linda every success in the future.

Ruth has joined the team and settled in very quickly developing her role within the Guildford Community. Ruth brings great experience and people skills which will benefit the charity as it continues to grow.

Becky, our Partnership Manager, has continued to develop her role and enabled the Charity to expand its reach within the local community. We are delighted to say that Gracie, Becky and Ruth combine as a great team with a real heart for the people we serve.

Financial Review

The Charity has reported a net small surplus of £368 for the year in line with the current policy of targeting a break-even outturn each year. The surplus has been transferred to unrestricted funds which totalled £2,199 at the balance sheet date. Support costs increased during the year, primarily because the Charity employed a Partnership Manager to help the Charity's growth and activity and develop links with the community and partners to link to potential participants of the courses.

Foodwise is still in its early stage of development and is funded by one main corporate entity which provides charitable donations to fund the activities of the Charity. As the Charity grows, it will seek to widen its funding base through online donations and other sponsorships. The Charity is currently considering adding online donation options to its website, which it hopes will be operational later this year.

Income from sponsorship and charitable donations increased this year to just over £17,000 to cover the costs of operating the charity. The main expenditures of the Charity are the costs of the Food Coaches, the Partnership Manager and food ingredients supplied on the courses run throughout the year.

The Charity runs its courses primarily from the Lighthouse in Woking, churches, schools and government buildings, all of which have been provided free of charge. Insurance for property is provided by the owners of the property with the Charity incurring costs for public liability and associated covers.

The primary corporate donator has confirmed its willingness to continue its financial support for the foreseeable future.

The Charity has not yet prepared a Reserves Policy as it is still in early development as an organisation and charity. The Trustees are aware of the need to establish an appropriate policy and a plan to implement it, as it becomes more established.

Future Developments

The co-ordination of the Partnership Manager role alongside multiple Food Coaches shows great potential and we continue to develop this operational structure. Our focus is to strengthen the relationships with our referral partners, with a key focus on schools. We have identified a need to feed certain children during school holidays, when free school meals are not available. We are seeking to expand our activities in this regard over the next year.

Our key aim is to improve cooking skills to improve the eating habits of people on lower incomes. Our further aim is to run courses with loneliness and dietary needs as a central focus. Again we will consider how all these core aims can work in harmony and best assist those relevant to the specific course.

We will seek to diversify the sources and number of donors providing the income for the charity, as well as its effectiveness in fulfilling its aims to ensure that funds are well spent and deliver real results and assistance for the people who seek, or are in need, of our help.
