- (1) MERTON PROPERTIES LIMITED (a company incorporated in England and Wales with company registration number 612958) whose registered office is at 16 South End Croydon CRo 1DN (the Chargor)
- (2) **Property Finance Nominees (No.3) Limited** (company number 03204842) whose registered office is at 49A High Street Ruislip Middlesex HA4 7BD (the **Lender**)

1. Covenant to pay

demand or notice delivered personally shall be deemed to have been received immediately upon delivery

18. Miscellaneous

- The Lender shall have the right to assign the whole or any part of the benefit of this Charge and the Lender shall be entitled to disclose any information relating to the Property and the Borrower to any actual or prospective assignee, successor or participant
- No delay or omission on the part of the Lender in exercising any right or remedy under this Charge shall impair that right or remedy or operate as or be taken to be a waiver of it, nor shall any single, partial or defective exercise of any such right or remedy preclude any other or further exercise under this Charge of that or any other right or remedy
- The Lender's rights under this Charge are cumulative and not exclusive of any rights provided by law and may be exercised from time to time and as often as the Lender deems expedient
- Any waiver by the Lender of any terms of this Charge or any consent or approval given by the Lender under it shall only be effective if given in writing and then only for the purpose and upon the terms and conditions, if any, on which it is given
