## ORDER

**UPON** the Application of John Paul Sugden and Rob Sadler for a block transfer Order dated 2020

#### IT IS ORDERED THAT:

1. John Paul Sugden ("outgoing officer holder") be removed from office in respect of each of the ongoing cases listed in Parts 1 and 2 of the Schedule attached to this Order ("block transfer cases") from the date of this Order.

- 10. In respect of any of the block transfer cases where the replacement office holder is appointed as joint office holder, any act required or authorised to be done by the joint office holders may be done by all or any one or more of them.
