**Central A1 Limited & 1,795 other Companies (together 'the Companies')
- All In Creditors' Voluntary Liquidation**

I set out below an annual progress report in accordance with Section 104A of the Insolvency Act 1986 and Rule 18.4 of the Insolvency (England and Wales) Rules 2016 ('the Rules'). This report covers the period 5 October 2017 to 4 October 2018 ('the Period') and should be read in conjunction with my previous reports.

1. Professional information regarding the Joint Liquidators

The Joint Liquidators are Malcolm Cohen (officeholder number: 6825) and Shane Crooks (officeholder number: 15110) of BDO LLP, 55 Baker Street, London, W1U 7EU. The Joint Liquidators were appointed on 5 October 2016 and carry out their functions jointly and severally, meaning any action can be done by one Liquidator or by both of them.

2. The Companies

Please note that the Joint Liquidators are appointed over 1,796 separate companies, details of which can be found on the schedule attached as Appendix 1. Given the close relationship between the Companies and the similarities in their affairs, I am issuing one, consolidated annual report for all of the Companies, which includes a consolidated summary of my receipts and payments for the Period.

The Joint Liquidators consider that reporting on a consolidated basis maximises efficiencies and reduces the costs of reporting which would otherwise be borne by the liquidation estates.

My previous annual report dated 4 December 2017 set out in detail the background to the Companies and the events leading up to their liquidation, therefore I do not propose to repeat that information in this report.

3. Settlement of the former liquidator's costs

Creditors will recall that, shortly after the Joint Liquidators' appointment, the former liquidator, Paul Appleton of David Rubin & Partners Limited ('DRP'), requested that DRP's outstanding reporting accountant fees be paid as an expense of the liquidation. DRP advised that the entire balance of the Companies' cash (c£2.88m) had been transferred into DRP's client account prior to the commencement of the liquidations. As noted in our previous report, the level of fees sought



by DRP would have substantially extinguished the cash balance held across the combined liquidation estates.

In the circumstances, the Joint Liquidators were unable to agree the level of fees being charged by DRP, and requested additional information in support of the fees.

On 28 October 2016, DRP commenced a Court application, to which the Joint Liquidators were named as Respondents, seeking various orders and declarations to the effect that the reporting accountant fee sought by DRP should be immediately paid as a reasonable and necessary expense of the liquidations. The Joint Liquidators defended this application, which resulted in protracted litigation and a three-day trial set to commence on 13 June 2017.

Shortly before the commencement of the trial, and following discussions between DRP and the Joint Liquidators, the application was settled between the parties. The terms of the settlement are confidential and cannot be disclosed by the Joint Liquidators, although we are able to advise that, as noted on the attached consolidated summary of our receipts and payments, a payment of c£2.122m was made to DRP in full and final settlement of DRP's reporting accountant fee (inclusive of VAT which has since been reclaimed by the Joint Liquidators).

This left a cash balance of c£767k (plus the VAT to be reclaimed) across the liquidation estates, which could then be applied towards the costs and expenses of the liquidations and allow for a dividend to be paid to creditors of the Companies with agreed claims.

4. Receipts and Payments

I attach, for your information, a consolidated summary of my receipts and payments, showing a balance in hand of £460,768.51. I comment specifically on certain items elsewhere in this report, otherwise I consider that this summary is self-explanatory.

5. Restoration of Dissolved Companies

As previously reported, subsequent to the appointment of the Joint Liquidators, 92 of the Companies ('the Dissolved Companies') were struck off the Register and dissolved by Companies House, due to delays in the processing of documents by Companies House confirming the appointment of the Joint Liquidators. The Dissolved Companies are listed at Appendix 2 of this report.

Due to their dissolution, the Joint Liquidators were unable to deal with the Dissolved Companies' assets until such time as they had been restored to the Register. Of the total funds held by the Joint Liquidators, c£193k related to the Dissolved Companies.

Following protracted discussions with the Government Legal Department ('GLD'), it was agreed that the Joint Liquidators should make an application to the County Court for Orders that the Dissolved Companies be restored to the Register. These Orders were sealed on 8 May 2018 and I am pleased to report that the Dissolved Companies have since been restored to the Register. They are now correctly recognised as being in Creditors' Voluntary Liquidation following the re-filing of the necessary documentation.

The statutory cost of restoration of a single company (excluding legal costs) is usually in the region of £300. Due to the large number of companies being restored the Joint Liquidators were able to negotiate with the GLD a discounted restoration fee of £125 per company. Accordingly, a payment of £11,500 has been made to the GLD as payment in full of the statutory costs of the restoration of the Dissolved Companies.

This payment is shown on the enclosed consolidated summary of my receipts and payments, however it should be noted that the £11,500 cost is to be borne by the Dissolved Companies only, and as such the level of funds in the estate of each of the Dissolved Companies has been reduced by £125.



Further, it was agreed with DRP that it would meet half of the total legal costs of the Joint Liquidators' lawyers, Holman Fenwick Willan LLP ('HFW'), incurred in respect of the restoration of the Dissolved Companies, which totalled £49,640.32 plus VAT. Accordingly, a payment of £24,820.16 plus VAT was received from DRP in settlement of half of HFW's costs (albeit after the Period, therefore this is not included in the consolidated summary of our receipts and payments).

The balance of the legal costs of restoration (£24,820.16 plus VAT) was settled shortly after the Period. These costs were apportioned to the estate of each of the Dissolved Companies, on a pro-rata basis dependant on the quantum of funds held in each of the Dissolved Company's estates. This approach is consistent with our apportionment to date of all other legal and liquidators' costs across the liquidation estates.

6. Investigations

The Joint Liquidators have a duty to investigate the affairs of the Companies and also the conduct of the directors and, in respect of the latter, to submit a confidential statutory report to the Secretary of State. I can confirm that such a report has been submitted.

In addition, I have carried out further investigations into the affairs of the Companies and the circumstances of their failure, to establish whether there are any other potential assets that could be realised for the benefit of the Companies' creditors. These investigations have included meeting with the director of the firm of accountants which previously provided services to the Companies, to discuss its role in the operations of the Companies, along with other stakeholders who might have been able to provide relevant information.

My investigations have now concluded and I am now taking steps to pay a dividend to unsecured creditors with agreed claims and close the liquidations.

7. Costs in the Liquidation

Legal fees and disbursements totalling £130,000 have been paid in the Period in relation to the costs associated with the dispute with the former liquidator. Our legal advisors, HFW, have further accrued costs and disbursements totalling £228,700.81 in respect of the same matter, of which it is anticipated that £56,645.47 will be settled from the liquidation estates. The balance is likely to be written off, as agreed with HFW, on the basis that there are insufficient funds with which to settle all outstanding costs after allowing for a dividend to be paid to creditors.

In addition, and as referred to at Section 5 above, legal costs of £49,640.32 plus VAT were incurred dealing with the restoration of the Dissolved Companies. These were settled after the Period, with 50% having been paid by the former liquidator.

8. Future of the Liquidations

Following completion of the restoration of the Dissolved Companies, the Joint Liquidators are now in a position to conclude outstanding matters in the liquidations and pay a first and final dividend to unsecured creditors, following which we should then take steps to close the liquidations.

9. Creditors

9.1. Secured Creditors

There are no secured creditors registered in respect of the Companies.



9.2. Preferential Creditors

The Companies had no employees at the date of appointment and consequently there are no preferential claims.

9.3. Unsecured Creditors

The Statements of Affairs prepared for each of the Companies stated that there were three creditors with aggregate unsecured creditor claims totalling £4,271,321.85. To date, unsecured claims of £35,893,135 have been received, predominantly consisting of HMRC's current claim of £35,533,935.

As has been previously reported, the Joint Liquidators have made provisions to allow for a 15% 'carve-out', which was specifically reserved from net realisations in the Companies' estates, to be made available for the benefit of creditors with agreed claims. The Joint Liquidators are now in a position to issue notice of intention to pay a first and final dividend in all of the liquidations, enclosed with this report.

9.4. Prescribed Part

Under Section 176A of the Insolvency Act 1986 where, after 15 September 2003, a company has granted a floating charge to a secured creditor, a proportion of the net property of that company must be made available purely for the unsecured creditors. The Companies have not granted floating charges to any creditor after 15 September 2003 and consequently there will be no Prescribed Part in these liquidations.

10. Joint Liquidators' Remuneration

Pursuant to the Rules, the Joint Liquidators are obliged to fix their remuneration in accordance with Rule 18.16. This permits remuneration to be fixed either:

- (1) as a percentage of the assets realised and distributed; and/or
- (2) by reference to the time the Joint Liquidators and their staff have spent attending to matters in the liquidation; and/or
- (3) as a set amount; and/or
- (4) as a combination of the above.

The Joint Liquidators' remuneration in respect of 1,704 of the Companies (being all of the Companies with the exception of the Dissolved Companies) was approved on a fixed set amount as detailed in the appendices to my previous report. These fees were approved by the majority of creditors and, as set out in my previous report, totalled c£411k.

To date, the Joint Liquidators have drawn £328,000 in respect of their remuneration, all of which was drawn in the Period as shown on the enclosed consolidated summary of the Joint Liquidators' receipts and payments. The balance of these fees will be drawn shortly.

We were not previously in a position to seek fee approval in respect of the Dissolved Companies, and instead awaited the outcome of our application for these to be restored to the Register. However, now that this matter has been resolved, the Joint Liquidators would like to seek approval of the basis of their remuneration in respect of the liquidations of the Dissolved Companies and wish to ask creditors to approve our remuneration on a fixed set amount.



We have therefore proposed a fixed fee of £131,211.94 across the liquidations of the Dissolved Companies which will ensure that, after settlement of the Joint Liquidators' fees and the remaining costs of the liquidations of those companies (being exclusively HFW's costs incurred in respect of the settlement of the former liquidator's costs, discounted as agreed with HFW), an overall sum equal to 15% of the net realisations received in all of the liquidations will be available for distribution to creditors with agreed claims. The request for fee approval on a fixed set amount is attached at Appendix 2.

For the purposes of comparison, I attach schedules detailing the time costs incurred by the Joint Liquidators and their staff for the Period and in the Liquidations to 4 October 2018. The consolidated time costs for dealing with the liquidations of the Companies are presently in the region of £729k, reflecting the considerable time that was required to be spent in dealing with the litigation and investigations into the Companies' affairs, including the Dissolved Companies. Creditors will therefore note that the consolidated fixed fee proposed by the Joint Liquidators (ie c£542k across all 1,796 companies, at an average of c£300 per company, including those which have already been approved) results in a far better outcome for the liquidation estates and the Companies' creditors than if fees were sought on a time costs basis.

Creditors are also advised that the combined time costs of the Joint Liquidators and their legal advisors accrued to date are significantly higher than the c£947k of net realisations after settlement of DRP's costs. Therefore, to ring-fence sufficient funds to enable the Joint Liquidators to pay a dividend to unsecured creditors as noted above, both the Joint Liquidators and their legal advisors (who in total have accrued but unpaid costs of circa £666k) will be required to write-off a substantial element of their time costs.

For guidance, I enclose a document that outlines the policy of BDO LLP in respect of fees and disbursements.

I would now ask creditors to consider approving the basis of the Joint Liquidators' remuneration for the Dissolved Companies. Under Section 246ZE of the Insolvency Act 1986, I attach a formal notice of a Decision Process by correspondence together with a written resolution for creditors' attention.

11. Joint Liquidators' Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. Total category 1 disbursements of £18,142 incurred to date in these Liquidations are detailed as follows:

The above category 1 disbursements were all paid in the Period. Since my last report, no additional category 1 disbursements have been incurred.

Some Liquidators recharge expenses, for example printing, photocopying and telephone costs, which cannot economically be recorded in respect of each specific case. Such expenses, which are apportioned to cases, require the approval of the creditors before they can be drawn, and these are known as category 2 disbursements. The policy of BDO LLP in respect of these liquidations is not to charge any category 2 disbursements.



12. Liquidation Committee

It is a requirement under Rule 6.19 of the Rules that, when convening a decision process, to at the same time deliver to creditors a notice inviting them to decide whether a Liquidation Committee should be established, if sufficient creditors are willing to be members of the committee.

To establish a committee there must be between three and five members. A guide to Liquidation Committees is available at <https://www.r3.org.uk/what-we-do/publications/professional/creditors-guides>.

If creditors wish to establish a Liquidation Committee, they should provide their consent on the attached Decision Process form.

In the event that a Liquidation Committee is not formed, I invite the creditors to consider approving the Joint Liquidator's remuneration. If a Liquidation Committee is appointed, it will be responsible for considering the resolutions.

13. Creditors' Decision Process

Please note that formal notice of Decision Process by Correspondence is attached covering matters set out above. Creditors may indicate their decision by completing and returning the written resolution form to this office by no later than the Decision Date, which is 21 December 2018. If a creditor has not already submitted a proof of debt, they must include one when returning the written resolution. A proof of debt is attached. Votes received after the Decision Date will not be counted.

If creditors wish to consider the resolutions at a physical meeting they must notify me in writing within five business days of delivery of the attached notice. A meeting will be convened if sufficient creditors notify the Joint Liquidators within the timeframe. Section 246ZE of the Act sets the 'minimum number' of creditors for requisitioning a meeting at any of the following:

- (a) 10% in value of the creditors or contributories; or
- (b) 10% in number of the creditors or contributories; or
- (c) 10 creditors or contributories.

14. Creditors' rights

I provide at the end of this report an extract from the Rules setting out the rights of creditors to request further information and/or challenge the remuneration or expenses within the liquidations. Creditors may access information setting out creditors' rights in respect of the approval of Liquidator's remuneration at <https://www.r3.org.uk/what-we-do/publications/professional/fees>.

Time spent on casework is recorded directly to the relevant case using a computerised time recording system and the nature of the work undertaken is recorded at that time. Units of time can be as small as 3 minutes. BDO LLP records work in respect of insolvency work under the following categories:-

- Pre Appointment
- Steps upon Appointment
- Planning and Strategy
- General Administration
- Asset Realisation/Management
- Trading Related Matters
- Employee Matters
- Creditor Claims
- Reporting
- Distribution and Closure
- Other Issues.

Under each of the above categories the work is recorded in greater detail in sub categories. Please note that the 11 categories provide greater detail than the six categories recommended by the Recognised Professional Bodies who are responsible for licensing and monitoring insolvency practitioners.

Where an officeholder's remuneration is approved on a time cost basis the time invoiced to the case will be subject to VAT at the prevailing rate.

Where remuneration has been approved on a time costs basis a periodic report will be provided to any committee appointed by the creditors or in the absence of a committee to the creditors. The report will provide a breakdown of the remuneration drawn and will enable the recipients to see the average rates of such costs.



Other Costs

Where expenses are incurred in respect of the insolvent estates they will be recharged. Such expenses can be divided into two categories:

Category 1

This heading covers expenses where BDO LLP has met a specific cost in respect of the insolvent estates where payment has been made to a third party. Such expenses may include items such as advertising, couriers, travel (by public transport), land registry searches, fees in respect of swearing legal documents etc. In each case the recharge will be reimbursement of a specific expense incurred.

Category 2

As previously reported, the policy of BDO LLP in respect of these liquidations is not to charge any category 2 disbursements. We also do not propose to recover from the estates the cost of travel where staff use either their own vehicles or company cars in travelling connected with the insolvency.

Certain Rules apply to decision procedures. The full text of the Rules is attached overleaf but the effect of those Rules is summarised here:

Creditor Voting rights (R.15.28): Every creditor who has this notice is entitled to vote in respect of the debt due to the creditor. Where there is a physical meeting the creditor must submit a proxy form (not relevant at this stage). Creditors, including creditors whose debt is treated as a 'small debt' (£1,000 or less) must still deliver a proof for voting purposes, if they have not already done so.

Calculation of creditors voting rights (R.15.31): In respect of these liquidations creditors' claims will be calculated as at the date of liquidation, being 5 October 2016. Claims that have an uncertain value will be valued at £1, or a higher value if the chair allows.

Requisite majority of creditors for making a decision (15.34): In a Creditors' Voluntary Liquidation a decision is approved if a majority of creditors, by value, vote in favour by the Decision Date.

Appeals against decisions (R.15.35): Decisions of the Joint Liquidators in convening the Decision Procedure and dealing with voting is subject to appeal to the court by a creditor. Any appeal must be made within 21 days of the Decision Date.

Physical Meeting: If creditors want to consider the resolutions at a physical meeting they must notify in writing the Joint Liquidators, whose details are above, within five business days of delivery of this notice. A meeting will be convened if sufficient creditors notify the Joint Liquidators within the timeframe. Section 246ZE of the Insolvency Act sets the 'minimum number' of creditors for requisitioning a meeting at any of the following:

- (a) 10% in value of the creditors or contributories; or
- (b) 10% in number of the creditors or contributories; or
- (c) 10 creditors or contributories.



Extract from the Insolvency (England and Wales) Rules 2016

Creditors' voting rights

15.28.—(1) In an administration, an administrative receivership, a creditors' voluntary winding up, a winding up by the court and a bankruptcy, a creditor is entitled to vote in a decision procedure or to object to a decision proposed using the deemed consent procedure only if—

- (a) the creditor has, subject to 15.29, delivered to the convener a proof of the debt claimed in accordance with paragraph (3), including any calculation for the purposes of rule 15.31 or 15.32, and
- (b) the proof was received by the convener—
 - (i) not later than the decision date, or in the case of a meeting, 4pm on the business day before the meeting, or
 - (ii) in the case of a meeting, later than the time given in sub-paragraph (i) where the chair is content to accept the proof; and
- (c) the proof has been admitted for the purposes of entitlement to vote.

(2) In the case of a meeting, a proxy-holder is not entitled to vote on behalf of a creditor unless the convener or chair has received the proxy intended to be used on behalf of that creditor.

(3) A debt is claimed in accordance with this paragraph if it is—

- (a) claimed as due from the company or bankrupt to the person seeking to be entitled to vote; or
- (b) in relation to a member State liquidator, claimed to be due to creditors in proceedings in relation to which that liquidator holds office.

(4) The convener or chair may call for any document or other evidence to be produced if the convener or chair thinks it necessary for the purpose of substantiating the whole or any part of a claim.

(5) In a decision relating to a proposed CVA or IVA every creditor, secured or unsecured, who has notice of the decision procedure is entitled to vote in respect of that creditor's debt.

(6) Where a decision is sought in an administration under sub-paragraph 3.52(3)(b) (pre administration costs), paragraph 18.18(4) (remuneration: procedure for initial determination in an administration) or paragraph 18.26(2) (first exception: administrator has made statement under paragraph 52(1)(b) of Schedule B1), creditors are entitled to participate to the extent stated in those paragraphs.

Calculation of voting rights

15.31.—(1) Votes are calculated according to the amount of each creditor's claim—

- (a) in an administration, as at the date on which the company entered administration, less—
 - (i) any payments that have been made to the creditor after that date in respect of the claim, and
 - (ii) any adjustment by way of set-off which has been made in accordance with rule 14.24 or would have been made if that rule were applied on the date on which the votes are counted;
- (b) in an administrative receivership, as at the date of the appointment of the receiver, less any payments that have been made to the creditor after that date in respect of the claim;
- (c) in a creditors' voluntary winding up, a winding up by the court or a bankruptcy, as set out in the creditor's proof to the extent that it has been admitted;
- (d) in a proposed CVA—
 - (i) at the date the company went into liquidation where the company is being wound up,
 - (ii) at the date the company entered into administration (less any payments made to the creditor after that date in respect of the claim) where it is in administration,
 - (iii) at the beginning of the moratorium where a moratorium has been obtained (less any payments made to the creditor after that date in respect of the claim), or
 - (iv) where (i) to (iii) do not apply, at the decision date;
- (e) in a proposed IVA—
 - (i) where the debtor is not an undischarged bankrupt—
 - (aa) at the date of the interim order, where there is an interim order in force,
 - (bb) otherwise, at the decision date,
 - (ii) where the debtor is an undischarged bankrupt, at the date of the bankruptcy order.

(2) A creditor may vote in respect of a debt of an unliquidated or unascertained amount if the convener or chair decides to put upon it an estimated minimum value for the purpose of entitlement to vote and admits the claim for that purpose.

(3) But in relation to a proposed CVA or IVA, a debt of an unliquidated or unascertained amount is to be valued at £1 for the purposes of voting unless the convener or chair or an appointed person decides to put a higher value on it.

(4) Where a debt is wholly secured its value for voting purposes is nil.

(5) Where a debt is partly secured its value for voting purposes is the value of the unsecured part.

(6) However, the value of the debt for voting purposes is its full value without deduction of the value of the security in the following cases—



- (a) where the administrator has made a statement under paragraph 52(1)(b) of Schedule B1 and the administrator has been requested to seek a decision under paragraph 52(2); and
 - (b) where, in a proposed CVA, there is a decision on whether to extend or further extend a moratorium or to bring a moratorium to an end before the end of the period of any extension.
- (7) No vote may be cast in respect of a claim more than once on any resolution put to the meeting; and for this purpose (where relevant), the claim of a creditor and of any member State liquidator in relation to the same debt are a single claim.
- (8) A vote cast in a decision procedure which is not a meeting may not be changed.
- (9) Paragraph (7) does not prevent a creditor or member State liquidator from—
- (a) voting in respect of less than the full value of an entitlement to vote; or
 - (b) casting a vote one way in respect of part of the value of an entitlement and another way in respect of some or all of the balance of that value.

Requisite majorities

- 15.34.—(1) A decision is made by creditors when a majority (in value) of those voting have voted in favour of the proposed decision, except where this rule provides otherwise.
- (2) In the case of an administration, a decision is not made if those voting against it—
- (a) include more than half in value of the creditors to whom notice of the decision procedure was delivered; and
 - (b) are not, to the best of the convener or chair's belief, persons connected with the company.
- (3) Each of the following decisions in a proposed CVA is made when three-quarters or more (in value) of those responding vote in favour of it—
- (a) a decision approving a proposal or a modification;
 - (b) a decision extending or further extending a moratorium; or
 - (c) a decision bringing a moratorium to an end before the end of the period of any extension.
- (4) In a proposed CVA a decision is not made if more than half of the total value of the unconnected creditors vote against it.
- (5) For the purposes of paragraph (4)—
- (a) a creditor is unconnected unless the convener or chair decides that the creditor is connected with the company;
 - (b) in deciding whether a creditor is connected reliance may be placed on the information provided by the company's statement of affairs or otherwise in accordance with these Rules; and
 - (c) the total value of the unconnected creditors is the total value of those unconnected creditors whose claims have been admitted for voting.
- (6) In a case relating to a proposed IVA—
- (a) a decision approving a proposal or a modification is made when three-quarters or more (in value) of those responding vote in favour of it;
 - (b) a decision is not made if more than half of the total value of creditors who are not associates of the debtor vote against it.
- (7) For the purposes of paragraph (6)—
- (a) a creditor is not an associate of the debtor unless the convener or chair decides that the creditor is an associate of the debtor;
 - (b) in deciding whether a creditor is an associate of the debtor, reliance may be placed on the information provided by the debtor's statement of affairs or otherwise in accordance with these Rules; and
 - (c) the total value of the creditors who are not associates of the debtor is the total value of the creditors who are not associates of the debtor whose claims have been admitted for voting.

Appeals against decisions under this Chapter

- 15.35.—(1) A decision of the convener or chair under this Chapter is subject to appeal to the court by a creditor, by a contributory, or by the bankrupt or debtor (as applicable).
- (2) In a proposed CVA, an appeal against a decision under this Chapter may also be made by a member of the company.
- (3) If the decision is reversed or varied, or votes are declared invalid, the court may order another decision procedure to be initiated or make such order as it thinks just but, in a CVA or IVA, the court may only make an order if it considers that the circumstances which led to the appeal give rise to unfair prejudice or material irregularity.
- (4) An appeal under this rule may not be made later than 21 days after the decision date.
- (5) However, the previous paragraph does not apply in a proposed CVA or IVA, where an appeal may not be made after the end of the period of 28 days beginning with the day—
- (a) in a proposed CVA, on which the first of the reports required by section 4(6) or paragraph 30(3) of Schedule A1 was filed with the court(a); or
 - (b) in a proposed IVA—
 - (i) where an interim order has not been obtained, on which the notice of the result of the consideration of the proposal required by section 259(1)(a) has been given, or
 - (ii) otherwise, on which the report required by section 259(1)(b)(b) is made to the court.



(6) The person who made the decision is not personally liable for costs incurred by any person in relation to an appeal under this rule unless the court makes an order to that effect.

(7) The court may not make an order under paragraph (6) if the person who made the decision in a winding up by the court or a bankruptcy is the official receiver or a person nominated by the official receiver.

Eligibility for membership of creditors' or liquidation committee

17.4.-(1) This rule applies to a creditors' committee in an administration, an administrative receivership, and a bankruptcy and to a liquidation committee in a creditors' voluntary winding up and a winding up by the court.

(2) A creditor is eligible to be a member of such a committee if—

- (a) the person has proved for a debt;
- (b) the debt is not fully secured; and
- (c) neither of the following apply—
 - (i) the proof has been wholly disallowed for voting purposes, or
 - (ii) the proof has been wholly rejected for the purpose of distribution or dividend.

(3) No person can be a member as both a creditor and a contributory.

(4) A body corporate may be a member of a creditors' committee, but it cannot act otherwise than by a representative appointed under rule 17.17.

Extract from the Insolvency Act 1986 (as amended)

Section 246ZE Decisions by creditors and contributories: general

(1) This section applies where, for the purposes of this Group of Parts, a person ("P") seeks a decision about any matter from a company's creditors or contributories.

(2) The decision may be made by any qualifying decision procedure P thinks fit, except that it may not be made by a creditors' meeting or (as the case may be) a contributories' meeting unless subsection (3) applies.

(3) This subsection applies if at least the minimum number of creditors or (as the case may be) contributories make a request to P in writing that the decision be made by a creditors' meeting or (as the case may be) a contributories' meeting.

(4) If subsection (3) applies P must summon a creditors' meeting or (as the case may be) a contributories' meeting.

(5) Subsection (2) is subject to any provision of this Act, the rules or any other legislation, or any order of the court—

- (a) requiring a decision to be made, or prohibiting a decision from being made, by a particular qualifying decision procedure (other than a creditors' meeting or a contributories' meeting);
- (b) permitting or requiring a decision to be made by a creditors' meeting or a contributories' meeting.

(6) Section 246ZF provides that in certain cases the deemed consent procedure may be used instead of a qualifying decision procedure.

(7) For the purposes of subsection (3) the "minimum number" of creditors or contributories is any of the following—

- (a) 10% in value of the creditors or contributories;
- (b) 10% in number of the creditors or contributories;
- (c) 10 creditors or contributories.

(8) The references in subsection (7) to creditors are to creditors of any class, even where a decision is sought only from creditors of a particular class.

(9) In this section references to a meeting are to a meeting where the creditors or (as the case may be) contributories are invited to be present together at the same place (whether or not it is possible to attend the meeting without being present at that place).

(10) Except as provided by subsection (8), references in this section to creditors include creditors of a particular class.

(11) In this Group of Parts "qualifying decision procedure" means a procedure prescribed or authorised under paragraph 8A of Schedule 8.

Statement from the Insolvency (England and Wales) Rules 2016 regarding the rights of creditors in respect of the Joint Liquidators' fees and expenses:

Creditors' and members' requests for further information in administration, winding up and bankruptcy

18.9.—(1) The following may make a written request to the office-holder for further information about remuneration or expenses (other than pre-administration costs in an administration) set out in a progress report under rule 18.4(1)(b), (c) or (d) or a final report under rule 18.14—

- (a) a secured creditor;
 - (b) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question);
 - (c) members of the company in a members' voluntary winding up with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company;
 - (d) any unsecured creditor with the permission of the court; or
 - (e) any member of the company in a members' voluntary winding up with the permission of the court.
- (2) A request, or an application to the court for permission, by such a person or persons must be made or filed with the court (as applicable) within 21 days of receipt of the report by the person, or by the last of them in the case of an application by more than one member or creditor.
- (3) The office-holder must, within 14 days of receipt of such a request respond to the person or persons who requested the information by—
- (a) providing all of the information requested;
 - (b) providing some of the information requested; or
 - (c) declining to provide the information requested.
- (4) The office-holder may respond by providing only some of the information requested or decline to provide the information if—
- (a) the time or cost of preparation of the information would be excessive; or
 - (b) disclosure of the information would be prejudicial to the conduct of the proceedings;
 - (c) disclosure of the information might reasonably be expected to lead to violence against any person; or
 - (d) the office-holder is subject to an obligation of confidentiality in relation to the information.
- (5) An office-holder who does not provide all the information or declines to provide the information must inform the person or persons who requested the information of the reasons for so doing.
- (6) A creditor, and a member of the company in a members' voluntary winding up, who need not be the same as the creditor or members who requested the information, may apply to the court within 21 days of—
- (a) the office-holder giving reasons for not providing all of the information requested; or
 - (b) the expiry of the 14 days within which an office-holder must respond to a request.
- (7) The court may make such order as it thinks just on an application under paragraph (6).

Remuneration and expenses: application to court by a creditor or member on grounds that remuneration or expenses are excessive

18.34.—(1) This rule applies to an application in an administration, a winding-up or a bankruptcy made by a person mentioned in paragraph (2) on the grounds that—

- (a) the remuneration charged by the office-holder is in all the circumstances excessive;
 - (b) the basis fixed for the office-holder's remuneration under rules 18.16, 18.18, 18.19, 18.20 and 18.21 (as applicable) is inappropriate; or
 - (c) the expenses incurred by the office-holder are in all the circumstances excessive.
- (2) The following may make such an application for one or more of the orders set out in rule 18.36 or 18.37 as applicable—
- (a) a secured creditor,
 - (b) an unsecured creditor with either—
 - (i) the concurrence of at least 10% in value of the unsecured creditors (including that creditor), or
 - (ii) the permission of the court, or
 - (c) in a members' voluntary winding up—
 - (i) members of the company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company, or



(ii) a member of the company with the permission of the court.

(3) The application by a creditor or member must be made no later than eight weeks after receipt by the applicant of the progress report under rule 18.3, or final report or account under rule 18.14 which first reports the charging of the remuneration or the incurring of the expenses in question ('the relevant report').

Applications under rules 18.34 and 18.35 where the court has given permission for the application

18.36.—(1) This rule applies to applications made with permission under rules 18.34 and 18.35.

- (2) Where the court has given permission, it must fix a venue for the application to be heard.
- (3) The applicant must, at least 14 days before the hearing, deliver to the office-holder a notice stating the venue and accompanied by a copy of the application and of any evidence on which the applicant intends to rely.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders—
- (a) an order reducing the amount of remuneration which the office-holder is entitled to charge;
 - (b) an order reducing any fixed rate or amount;
 - (c) an order changing the basis of remuneration;
 - (d) an order that some or all of the remuneration or expenses in question is not to be treated as expenses of the administration, winding up or bankruptcy;
 - (e) an order for the payment of the amount of the excess of remuneration or expenses or such part of the excess as the court may specify by —
 - (i) the administrator or Liquidator or the administrator's or Liquidator's personal representative to the company, or
 - (ii) the trustee or the trustee's personal representative to such person as the court may specify as property comprised in the bankrupt's estate;
 - (f) any other order that it thinks just.
- (5) An order under paragraph (4)(b) or (c) may only be made in respect of periods after the period covered by the relevant report.
- (6) Unless the court orders otherwise the costs of the application must be paid by the applicant, and are not payable as an expense of the administration, winding up or bankruptcy.

Applications under rule 18.34 where the court's permission is not required for the application

18.37.—(1) On receipt of an application under rule 18.34 for which the court's permission is not required, the court may, if it is satisfied that no sufficient cause is shown for the application, dismiss it without giving notice to any party other than the applicant.

- (2) Unless the application is dismissed, the court must fix a venue for it to be heard.
- (3) The applicant must, at least 14 days before any hearing, deliver to the office-holder a notice stating the venue with a copy of the application and of any evidence on which the applicant intends to rely.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders—
- (a) an order reducing the amount of remuneration which the office-holder is entitled to charge;
 - (b) an order reducing any fixed rate or amount;
 - (c) an order changing the basis of remuneration;
 - (d) an order that some or all of the remuneration or expenses in question be treated as not being expenses of the administration or winding up or bankruptcy;
 - (e) an order for the payment of the amount of the excess of remuneration or expenses or such part of the excess as the court may specify by —
 - (i) the administrator or Liquidator or the administrator's or Liquidator's personal representative to the company, or
 - (ii) the trustee or the trustee's personal representative to such person as the court may specify as property comprised in the bankrupt's estate;
 - (f) any other order that it thinks just.
- (5) An order under paragraph (4)(b) or (c) may only be made in respect of periods after the period covered by the relevant report.
- (6) Unless the court orders otherwise the costs of the application must be paid by the applicant, and are not payable as an expense of the administration or as winding up or bankruptcy.
