The company has worked jointly with the University of Portsmouth over the past year to run the lottery-funded "Women's Community Activism Project", recording and editing two videos for the project website: - http://womenscommunityactivism.projects.portsmouthuni.ac.uk

During the course of the project the company was engaged in providing detailed technical and administrative support, including gratis consultancy work. The company also co-ordinated and trained volunteers in the local community and students at the University of Portsmouth.

The company carried out photographic research using collections held at Portsmouth City Council, The Spring at Havant and Greenham Common Control Tower.

The company also worked with Portsmouth City Council History Centre, Portsdown University of the Third Age, AgeUK, Historical Association (Portsmouth Branch), Somers Town Community Centre (The Hub), Paulsgrove Community Centre, Tipner and Stamshaw Community Centre, Fratton Community Centre and the National Museum of the Royal Navy (NMRN).

This project was of immense benefit to the local community. It created a permanent audio-visual archive of the personal histories of 56 women who had been involved in campaigning in Portsmouth for improvements to their lives and communities. It spanned the fight for better local housing and the liberation of women in the 1960's through campaigns against nuclear disarmament and racial prejudice to the concerns of the twenty-first century, such as climate change. This primary source archive is now held at Portsmouth History Centre.

The company also shot and produced the "Dockyard Gate" video for "Dark Side Port Side" - an interactive walk - part of "Sailortown", the University of Portsmouth's Port Towns and Urban Cultures project. This project was a showcase for collaborations between local videographers and local poets and scriptwriters and was made in collaboration with poet Eileen Phyall. https://darkside.nautoguide.com/

The company worked in collaboration with Big Screen Portsmouth to show the video "The Longest Night" in the Guildhall Square Portsmouth on the anniversary of the blitz on Portsmouth of January 10th 1941. This video is a 40 minute documentary made by Elephant in Scarlet's predecessor company, "Portsea Living History Project" which, in 2005, recorded eye-witness accounts of the raid. This video is shown every year to remind the city of the heroism and resilience of the local community.

The company has continued to grow its relationship with local charities and organisations and is currently bidding for Lottery funding for a new heritage project for 2022.
