

**UPON** reading the letter dated 3<sup>rd</sup> July 2018 from Freeths LLP, the solicitors acting for Paul Davis, indicating that Mr. Davis has agreed to the appointment of Paul Allen as an additional administrator of the above-named company following the failure of the process for selection of an additional administrator contained in the Order of HHJ Pelling QC dated 6 June 2018

**AND UPON** the solicitors for the other parties referred to in the said Order having indicated their consent to such appointment and Mr. Allen having provided his signed Consent to Act

**IT IS ORDERED THAT:**

1. Paul Allen be appointed to act as administrator of Bitcoin Global Capital Limited (in administration) jointly with Mr Davis.
2. Pursuant to paragraph 100(2) of Schedule B1 of the Insolvency Act 1986 any function to be exercised or performed by the Joint Administrators may be done by either or both of the Joint Administrators for the time being holding office acting jointly or otherwise.
3. There shall be no order as to costs.
