

PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT In the space provided below, please insert a general account of the company's activities in the financial year to which the report relates, including a description of how they have benefited the community.

Catbytes CIC is a social enterprise which promotes digital inclusion in the borough of Lewisham. Digital exclusion is experienced by many people in Lewisham. It has two main forms:

- 1. Lacking a device which can enable digital tasks to be performed, and/or lacking an internet connection
- 2. Lacking the knowledge of how to use technology to perform these tasks

Very often these two kinds of exclusion are experienced by people simultaneously. Our aim is to provide a complete service to people who are digitally excluded. We provide them with a device, and also train them to use it. We do this by requesting donations of second hand laptops, pcs and tablets from the public. These devices are refurbished by volunteers. They are then put on our "device library". They are distributed to our clients on a loan basis, also by volunteers. We also teach clients how to use these devices, either in our drop in clubs, called "Digital drop-ins", or in their own homes. We call the volunteers who provide training "digital buddies".

Catbytes is put in touch with clients for our service by organisations that support people who are likely to be digitally excluded. These include organisations that support the elderly, people with mental health difficulties, refugees, isolated individuals and homeless people. We call these organisations "referrers".

We also support local organisations, such as community centres and local charities, with a range of IT related issues. These include provision of equipment, troubleshooting, support with setting up and hosting websites and installing wifi.

At the beginning of 2021 the schoolchildren were required to log in remotely to classes in order to do homework. At this time the computers being supplied by the government had not come through, and therefore thousands of children in Lewisham were effectively absent from school. We launched a campaign to get more donations for laptops. Fortunately, this was a high profile issue in the media, and we were able to get lots of donations of devices. The schools were good at returning the laptops after they had been used, so these have stayed in the library. We managed to support 5 schools in Lewisham through this campaign.

As places have started to open up after the end of the lockdown, we have reopened our two longstanding clubs for drop in visitors. We have also started supporting other community organisations in the borough to provide digital support. This has been done by sending digital buddies to their social clubs. An example has been the social supermarket at St Peter's church in Brockley, where we now have a digital buddy regularly attending to give people support with using a device. At the beginning of 2022 we have 3 of these satellite digital buddying clubs running, alongside the 2 regular clubs.

Catbytes gave support to two projects during 2021. One was a project run with Lewisham Homes called "Tech-enabled care". This project involved supporting 17 residents of Lewisham Homes supported living accommodations to use Zoom to access some online social events. The events were hosted by Lewisham Homes independent living officers, and included quizzes and discussions. The residents were provided with tablets with SIM cards for the sessions. Catbytes trained the residents to use Zoom, set up emails, and gave technical support at the sessions themselves.

Catbytes also gave support to a project run by the local CCG. This was to support users of the Community Falls service use Zoom to access fitness sessions. The aim of these sessions is to give elderly people support in maintaining balance and preventing falls. Catbytes received £7000 of funding for the project. However, by the end of it we had only been requested to support 5 people in using the service. The remote sessions were not as popular as the face to face classes. The CCG kindly donated the remainder of the fund to Catbytes, for the purpose of repairing donated laptops. This came to £5000.

At the end of 2021, we made a funding application to Lewisham Council for main grant funding, under the title "Digital Access For All". This application was successful. It was made in conjunction with Lewisham Local, a Lewisham based volunteering organisation. The terms of this application require Catbytes to be the delivery partner in a programme to expand our digital drop ins across the borough.

PART 2 – CONSULTATION WITH STAKEHOLDERS – Please indicate who the company's stakeholders are; how the stakeholders have been consulted and what action, if any, has the company taken in response to feedback from its consultations?

Catbyte's' stakeholders are organisations or individuals based in the borough of Lewisham, or in some cases the adjacent boroughs, Greenwich, Southwark, Bromley and Croydon.

Many of our clients come to our digital drop-ins which help people learn basic internet skills. Consultation with them is carried out by personal interaction. We are concerned to make sure that learners enjoy the experience they have with us and find it worthwhile. Any complaints they have about volunteers are followed up by discussion with the volunteers. So far there have been few, and it has been possible to handle them without any formal disciplinary procedure.

We have over 55 referrer organisations who make requests for us to support clients, either to obtain a device, or to learn how to use one, or both. In order to do this, the referrer organisations register on our website https://catbytes.community. Once logged in, a referrer can make requests on behalf of their client which Catbytes processes.

The volunteers at the techy tea clubs are an important asset. We maintain a close personal relationship with them. Any comments or complaints made are taken very seriously, and are followed up by the director. We provide free DBS checks and organise one social activity a year. We will review this record to see if it could be improved.

Ewart Community Hall has been the venue for many of the Techy Tea clubs. We have a close relationship with them, and they have not charged us for use of their facility. They recognise what we are doing is for the benefit of the community.

The monitoring guidelines for the Digital Access For All project were made with and approved by a council representative. We have quarterly appraisals of our success in meeting our agreed targets. We are working closely with Lewisham Local in carrying out the work of this project. Their role is to manage relations between organisations who are interested in digital inclusion in Lewisham. An example of how they do this is holding meetings describing the work that is being carried out, in order to increase engagement with it.

We are also a member of a number of panels in Lewisham relating to digital inclusion. These include the Data Poverty Action Alliance, led by Phoenix Community Housing, and Lewisham Local's consultative group which is working with Lewisham Council to form its digital strategy for Lewisham.
