PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT In the space provided below, please insert a general account of the company's activities in the financial year to which the report relates, including a description of how they have benefited the community.

Catbytes CIC is a social enterprise which promotes digital inclusion in the borough of Lewisham. Digital exclusion is experienced by many people in Lewisham. It has two main forms:

- 1. Lacking a device which can enable digital tasks to be performed, and/or lacking an internet connection
- 2. Lacking the knowledge of how to use technology to perform these tasks

Very often these two kinds of exclusion are experienced by people simultaneously. Our aim is to provide a complete service to people who are digitally excluded. We provide them with a device, and also train them to use it. We do this by requesting donations of second hand laptops, pcs and tablets from the public. These devices are refurbished by volunteers. They are then put on our device library. They are distributed to our clients on a loan basis, also by volunteers. We also teach clients how to use these devices, either in our drop in clubs, called Digital drop-ins, or in their own homes. We call the volunteers who provide training "digital buddies".

Catbytes is put in touch with clients for our service by organisations that support people who are likely to be digitally excluded. These include organisations that support the elderly, people with mental health difficulties, refugees, isolated individuals and homeless people. We call these organisations referrers.

We also support local organisations, such as community centres and local charities, with a range of IT related issues. These include provision of equipment, troubleshooting, support with setting up and hosting websites and installing wifi.

At the end of 2021, we made a funding application to Lewisham Council for main grant funding, under the title Digital Access For All. This application was successful. It was made in

conjunction with Lewisham Local, a Lewisham based volunteering organisation. The terms of this application require Catbytes to be the delivery partner in a programme to expand our digital drop ins across the borough. The funding enabled us to recruit a new staff member, Nanssi Philippe.

Since Nanssi joined, we increased the number of digital drop-ins in the borough to 10. This has enabled us to deliver over 1000 buddying sessions of two hours each, to over 300 unique individuals. Our website now enables us to record who attends each session for the purpose of more accurate monitoring.

We have continued to donate laptops, smartphones and tablets. We distributed 330 during this year. We have increased the number of organisations that refer to us by 58. Now all referrers can make referrals through our website. We have increased our volunteer numbers by 27.

We gave 75 desktop computers to organisations based in the borough. We built two websites for local community organisations.

We have partnered with James Stevens of SPC.org. James is an expert in building intranet networks for local community projects. With his help we improved the Wifi quality of four community centres in the borough.

We collaborated with a local training school called Collabta, who support young NEET people to develop professional skills. One of our volunteers, John, trained a young man to write code to program arduinos. The training was carried out at our centre in Forest Hill.

We ran a film event for the Lewisham Borough of Culture year. The event show cased films made by senior citizens who ae members of the Stanstead Lodge club in Catford. There were 50 attendees at the event, including the Mayor, Brenda Dacres, who gave a speech.

Catbytes' stakeholders are organisations or individuals based in the borough of Lewisham, or in some cases the adjacent boroughs, Greenwich, Southwark, Bromley and Croydon.

Many of our clients come to our digital drop-ins which help people learn basic internet skills. Consultation with them is carried out by personal interaction. We are concerned to make sure that learners enjoy the experience they have with us and find it worthwhile. Any complaints they have about volunteers are followed up by discussion with the volunteers. So far there have been few, and it has been possible to handle them without any formal disciplinary procedure.

We have over 60 referrer organisations who make requests for us to support clients, either to obtain a device, or to learn how to use one, or both. In order to do this, the referrer organisations register on our website https://catbytes.community. Once logged in, a referrer can make requests on behalf of their client which Catbytes processes.

The volunteers at the techy tea clubs are an important asset. We maintain a close personal relationship with them. Any comments or complaints made are taken very seriously, and are

followed up by the director. We provide free DBS checks and organise one social activity a year. This year we have introduced a volunteer induction pack. It includes the policies that we believe the volunteers should be familiar with, and a general introduction to our purpose and vision.

This year we have introduced digital drop-ins that are being managed by the staff remotely. We monitor attendance and get feedback from the buddies at the drop-ins. We have made sure we keep constant contact with the buddies. One of the techniques we use is setting up a WhatsApp group for each drop-in. There is also a general WhatsApp group for buddies.

Ewart Community Hall has been the venue for many of the Techy Tea clubs. We have a close relationship with them, and they have not charged us for use of their facility. They recognise what we are doing is for the benefit of the community.

The monitoring guidelines for the Digital Access For All project were made with and approved by a council representative. We have quarterly appraisals of our success in meeting our agreed targets. We are working closely with Lewisham Local in carrying out the work of this project. Their role is to manage relations between organisations who are interested in digital inclusion in Lewisham. An example of how they do this is holding meetings describing the work that is being carried out, in order to increase engagement with it.

We are also a member of a number of panels in Lewisham relating to digital inclusion. These include the Data Poverty Action Alliance, led by Phoenix Community Housing, and Lewisham Local's consultative group which is working with Lewisham Council to form its digital strategy for Lewisham.

We have strengthened our relationship with key referral partners, and have started referring to them in some cases. For example, the 999 club, a homelessness support charity refer to us for laptops for their clients. We now also refer beneficiaries of our service to them if we think they are at risk of homelessness.
