

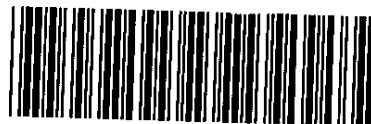

**ORDER**

---

**UPON** the Applicants' Application dated 1 May 2018 ("the Application")

**AND UPON** the Secretary of State having been duly served with a copy of the Application and supporting documentation and subsequently confirming there is no objection to the transfer;

**AND UPON** reading the evidence in support, namely the first witness statements of Claire Buijs, Hasib Howlader and Michelle Mills dated 30 April 2018 and the second witness statement of Michelle Mills dated 30 May 2018;

**AND UPON** there being no response;

**IT IS ORDERED THAT:**

- 1 Claire Buijs ("**the First Applicant**") and Hasib Howlader ("**the Second Applicant**") be removed as Officeholders to be replaced by Michelle Mills as sole appointee ("**the Replacement Officeholder**") as set out at paragraphs 2 to 6 below. The consent of the Replacement Officeholder to act is contained within her witness statement.
- 2 The First Applicant and Second Applicant be removed from office as Liquidator and/or Joint Liquidator of the companies in Creditors' Voluntary Liquidation listed in Schedule 1 attached hereto with effect from the date of this order and the Replacement Officeholder be appointed as sole Liquidator in substitution in respect of the said companies with effect from the date of this order, pursuant to section 108 of the Insolvency Act 1986.
- 3 The First Applicant and Second Applicant be removed from office as Joint Liquidator of the companies in Members' Voluntary Liquidation listed in Schedule 2 attached hereto with effect from the date of this order and the Replacement Officeholder be appointed as Sole Liquidator in substitution in respect of the said companies with effect from the date of this order, pursuant to section 108 of the Insolvency Act 1986.
- 4 The First Applicant and Second Applicant be removed from office as Joint Liquidator of the company in Compulsory Liquidation listed in Schedule 3 attached hereto with effect from the date of this order and the Replacement Officeholder be appointed as Sole Liquidator in substitution in respect of the said company with effect from the date of this order, pursuant to section 172 of the Insolvency Act 1986.
- 5 The First Applicant be removed from office as Supervisor of the companies in Company Voluntary Arrangements listed in Schedule 4 attached hereto with effect from the date of this order and the Replacement Officeholder be appointed as Sole Supervisor in substitution in respect of the said companies as specified in Schedule 5, with effect from the date of this order, pursuant to section 7 and paragraph 39(6) of Schedule A1 of the Insolvency Act 1986.
- 6 The First Applicant and Second Applicant be removed from office as Supervisor and/or Joint Supervisors of the Individual Voluntary Arrangements listed in Schedule 5 attached hereto with effect from the date of this order and the Replacement Officeholder be appointed as Sole Supervisor in substitution with effect from the date of this order, pursuant to section 263(5) of the Insolvency Act 1986.

- 7 The First Applicant and Second Applicant be removed and replaced, as set out at paragraphs 2 to 6 above, in each of the cases contained in Schedules 1 to 5 from the date of this order without being required to (i) apply to the Secretary of state for release or discharge as appropriate pursuant to s173(2)(b), s 174(4)(b) and s299(3)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payment account.
- 8 The Applicants shall file a copy of this order with the court listed in Schedule 3.
- 9 The Applicants shall file a copy of this order with the court listed in Schedule 3. Without incurring any additional expense for any of the said estates, the relevant Applicant or Replacement Officeholder shall notify each creditor of this Application and this Order by way of notice at the same time as the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:
- 9.1 An explanation of the effect of the Order;
- 9.2 Express reference to the liberty to apply contained in paragraph 12 below;
- 9.3 In the case of Liquidations where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rule 6.25 of the Insolvency (England and Wales) Rules 2016 has not already been provided as part of the report, it is open to that committee to require the relevant Applicant or Replacement Officeholder to provide an account of the administration of the estate, including:
- 9.3.1 A summary of receipts and payments;
- 9.3.2 A statement that he/she has reconciled his/her accounts.
- 9.4 In the case of Liquidations where no Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the relevant Applicant, Respondent or Replacement Officeholder do provide an account of the administration of the estate, including:
- 9.4.1 A summary of receipts and payments;
- 9.4.2 A statement that he/she has reconciled his/her accounts.
- 9.5 Notification that if any Applicant or Replacement Officeholder has been required to provide the information referred to in sub-paragraphs 9.3 and 9.4 above, whether by a Liquidation Committee or Creditors' Committee or by court order on the application of any creditor(s), the costs of any appointed Officeholder of so complying will, unless

there are good reasons to the contrary, be paid as an expense of the winding up as the case may be; and

- 9.6 In the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the appointed Officeholder to supply a statement of receipts and payments free of charge.
- 9.7 In the case of the Voluntary Arrangements, the provision of all such information as might reasonably be required with regard to the conduct of the Voluntary Arrangement.
- 10 The Replacement Officeholder shall, when the next routine report is due to the creditors of each appointment, give written notice of the making of this Order to each such creditor, such notice to include the following matters:-
- 10.1 an explanation as to the effect of the Order; and
- 10.2 express reference to the liberty to apply as set out in the Order.
- 11 The creditors in each of the cases listed in Schedules 1 to 5 shall be notified of this order by way of one composite notice (**"the Advertisement"**) to be published in the Gazette within 21 days of receipt of the sealed order.
- 12 Each creditor of each liquidation and voluntary arrangement case, who has an objection to this Order, has liberty to apply to vary or discharge this Order. Creditors shall have 56 days from the date of the Advertisement to apply to court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the cases listed in Schedule 1 to 5 until further or other order by the court.
- 13 The Replacement Officeholder shall file any appropriate notices in respect of the removal of the First and Second Applicant and the appointment of the Replacement Officeholder appointed pursuant to paragraphs 2 to 6 of this Order with the Registrar of Companies and the Secretary of State for Business Energy Innovation and Skills (Insolvency Service) as appropriate and as soon as reasonably practicable.
- 14 In the cases listed in Schedules 1 to 5 the First and Second Applicant be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to his/her conduct as officeholder of the estates after 56 days from the date of the Advertisement, unless otherwise ordered by the Court.
- 15 Subject to paragraph 16 below, in the event that, as a result of the implementation of this Order, Hudson Weir Ltd (**"Hudson Weir"**) incurs any additional cost in respect of the administration of those estates where the First Applicant and Second Applicant were Officeholders (that is to say over and above those costs incurred in the ordinary course of the administration of those

estates), those costs shall be borne by Hudson Weir and shall not be charged as an expense of the administration of those estates.

- 16 Nothing contained in paragraphs 15 or 17 shall prejudice the Applicants from charging to each individual estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that estate.
- 17 The costs of this Application (including VAT) shall be met by Hudson Weir.
- 18 The Replacement Officeholder has the right to apply to the court to amend this Order to include any appointments held by the First and Second Applicants which have been inadvertently omitted from the Application.
- 19 Such further or other order or direction as the court thinks fit.
