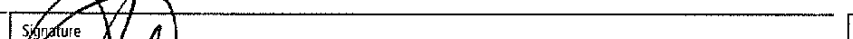

ORDER

BEFORE District Judge Matharu sitting in chambers on 3 March 2021
UPON the application of the Applicants dated February 2021 for a block transfer order
AND UPON READING the papers on the court file recorded as having been read

AND UPON the Secretary of State being served with Notice of this application in accordance with Rule 12.37
Insolvency Rules 2016

IT IS ORDERED that:-

1. Each of the County Court cases listed in Schedule 1 attached to this order (the "**Schedule**") be transferred to the High Court of Justice, Chancery Division, Manchester District Registry for the purpose only of making this order.
2. Immediately upon this order taking effect, the County Court cases listed in the Schedule be transferred back to the County Court.

3. Ian Edward Walker (the "**outgoing office-holder**") be removed from office in respect of each of the on-going cases listed in the Schedule (the "**block transfer cases**") from the date of this order.
4. Scott Kippax (the "**replacement office-holder**") be appointed as replacement office- holder in respect of each of the block transfer cases listed in the Schedule from the date of this order.
5. The creditors in each of the block transfer cases shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date of this order. An advertisement containing the information set out in the Schedule shall be sufficient to comply with the requirements of rule 1.6 and Chapter 4 of Part 1 (rules 1.10 to 1.14) of the Rules.
6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the block transfer cases listed in the Schedule who has an objection to this order shall have 21 days from the date of the publication of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedule unless otherwise ordered by the court.
7. The replacement office-holder shall as soon as reasonably practicable give notice of the terms of this order to the Secretary of State and in respect of the liquidations and administrations listed in the Schedule, to the Registrar of Companies.
8. The outgoing office-holder shall file a copy of this order with each of the courts listed in the Schedule and/or the Office of the Adjudicator, as applicable.
9. The outgoing office-holder shall receive his release as administrator, liquidator or trustee in bankruptcy 21 days after the date of the publication of the advertisement referred to at paragraph 5 of this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this order, in so far as his release relates to the specific case which is subject to that application.
10. The outgoing office-holder shall receive his release as provided for under paragraph 9 of this order without being required to (i) apply to the Secretary of State for his release or discharge as appropriate pursuant to s.173(2)(b), s.174(4)(b) and s.299 of the Insolvency Act 1986 as the case may be or (ii) being required to file a receipts and payments account.
11. The replacement office-holder shall in the next progress report after the date of this order, notify creditors or, in the case of any members' voluntary liquidation, members of the making of this order. In the case of those block transfer cases where the final account or the final report has already been delivered and the statutory time limit for a creditor or a member making any further representations or applications has expired or will expire within 8 weeks; publication of the advertisement in accordance with paragraph 5 of this order alone shall be deemed sufficient delivery of notice of this order under rule 12.38(6)(b)(i) of the Rules.
12. In respect of each of the block transfer cases listed in Part 1 of the Schedule, for the purposes of paragraph 83(7) of Schedule B1 to the Insolvency Act 1986, the replacement office-holder shall become the nominated liquidator in place of the outgoing office-holder.
13. In respect of each of the block transfer cases where the replacement office-holder is appointed as joint office-holder, any act required or authorised to be done by the joint office-holders may be done by all or any one or more of them.
14. Such further or other order or direction as the court sees fit.
