account referred to in paragraph 5 of the Witness Statement of Richard Ashton Bell dated the 9<sup>th</sup> September 2019 (the action) according to law

- (B) he will notify the Registrar of Companies immediately on the conclusion of the action
- (C) the director of the company or a majority of them will immediately on the expiry of 3 months from the conclusion of the action apply to the Registrar of Companies for the voluntary strike off of the company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application

AND UPON the Claimant and the solicitor for the Registrar of Companies (the Defendant) both consenting to this Order :

IT IS ORDERED THAT:

- (1) the name of the above named R.A. Bell Ltd be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 10013576 Ltd

(3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
