

The Great Whitchurch Pub Race Bonfire and Firework Night We'll Meet Again

Each event provides local outdoor activities and entertainment for the community of Whitchurch. In total the events reach out to and are enjoyed by 4000+ persons from the local community. The events are specifically designed to ensure they appeal to all age ranges throughout the town.

Sadly the Mayday event was dropped for 2019 due to a low take up of volunteers but its hoped that this event will return for 2020.

Whitchurch CIC continues to provide wholesome fun family events, and the directors are now moving their focus to raising the profile of volunteer requirements to ensure that all the events carry on.

Additional efforts to improve volunteer numbers is being driven between Whitchurch CIC and the Whitchurch Town council and other volunteer groups in Whitchurch. Everyone is very positive that the additional persons will come on board to ensure the success of the CIC continues in the forthcoming years.

Whitchurch C.I.C. has provided equipment for various community activities including youth clubs and music events. All resources remain open for use by the community of Whitchurch.
