## IT IS RESOLVED:

- 1. - 2. THAT the Board is unconditionally authorised to approve any reasonable additional terms that any third party fund, investing more than £750,000 in the new shares as approved by Resolution 1 above, which the Board believes, after due consideration, to be in the best interests of the Company.
- 3. THAT, in accordance with section 569 of the Companies Act 2006 (CA 2006), the directors of the Company be generally empowered to allot equity securities (as defined by section 560 of the CA 2006) as if section 561 of the CA 2006 did not apply to any such allotment.
- 4. That the issue and allotment of the shares outlined in Resolution 1 above (Allotment) be and is hereby approved and we hereby agree and consent, pursuant to clause 8.1(e) of the Shareholders' Agreement relating to the Company dated 26 June 2023, and for all other purposes, to the Allotment.
