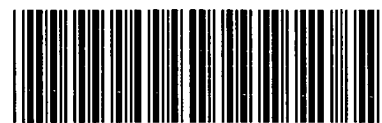



Notes to the financial statements

as at 31 December 2021

1. Principal accounting policies

Statement of compliance

The financial statements have been prepared and approved by the Directors in accordance with UK adopted international accounting standards in conformity with the requirements of the Companies Act 2006.

Basis of preparation

At 31 December 2021, the Company had adopted all IFRS and IFRIC interpretations that had been issued by the International Accounting Standards Board (IASB) and IFRIC except those which are not yet effective.

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

Cash and cash equivalents

Cash and cash equivalents comprise balances callable on demand or with less than three months maturity from the date of acquisition, including cash and balances with Standard Chartered Bank and callable on demand.

Accounting standards issued but not yet effective

IFRS 17 Insurance Contracts was issued in May 2017 to replace IFRS 4 Insurance Contracts. The effective date has been deferred to 1 January 2023. There is no impact on the results of the Company.
