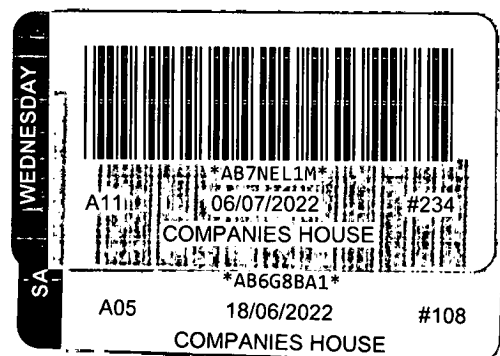





As a Charitable Interest Company, all directors are volunteers and receive no financial remuneration.






