Notes to the financial statements

Green Garden Gnome Nominee Limited ("the Company") is a company limited by shares and incorporated in England and Wales. The registered office is 8th Floor 1 Fleet Place, London, England, EC4M 7RA.

The purpose and principal activity of the Company is to act as nominee on behalf of its shareholders.

These financial statements replace the previously submitted accounts, and are now the statutory accounts for the year ended 30 June 2018. They are prepared as they were at the date of the original accounts.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest pound.

The Directors of the company have elected not to include a copy of the profit and loss within the financial statements.

These accounts are prepared for the year ended 30 June 2018.

For the year ended 30 June 2018 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

Restatement

The Balance Sheet figures for the current year and comparative period have both been restated.

The assets previously recognised on the Balance Sheet have been derecognised in order to reflect the nominee status by which the Company holds these assets.


