



ORDER

UPON considering the Applicant's application dated 27 November 2018 challenging the appointment of Joint Administrators

UPON the court ordering on 30 January 2019 that the Joint Administrators be treated as Second Respondent, though not formally added to these proceedings

UPON hearing Mr Mohammed of counsel for the Applicant, Ms Bowmaker of counsel for the First Respondent and Ms Pyper of counsel for the Second Respondent.

AND UPON giving judgement herein

IT IS DECLARED THAT:

1. Ms Erika Gertraut Jeep Morris was not duly or validly appointed as director of Sprout Land Holdings Limited on 19 November 2018 or thereafter.
2. The appointment of the Joint Administrators on 19 November 2018 was invalid.

AND IT IS ORDERED THAT:

1. The Joint Administrators be added to these proceedings as the Second Respondent.
2. The Administration of Sprout Land Holdings Limited shall cease today at 5.11pm.
3. The First Respondent shall pay the Applicant her costs of the Application summarily assessed in the sum of £7,500 inclusive of VAT.
4. The Second Respondent's claim for an indemnity under paragraph 34 of Schedule B1 of the Insolvency Act 1986 against the First Respondent, and costs as between the Respondents, be adjourned to the first open date after 8 March 2019 with a time estimate of 1 hour, reserved to ICC Judge Prentis.
