NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2018

1. General information

Mosach Properties Limited (the "Company") is domiciled and incorporated in England & Wales and its registration number is 10312956. The company is a private company limited by shares. The address if its registered office is The Coach House Southwood, Buckhurst Road, Westerham, Kent, England, TN16 2HR.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The following principal accounting policies have been applied:

2.2 Going concern

The Company has made a loss for the period of £1,629 and has net current liabilities of £4,261. The directors have confirmed they will provide support to the Company as required to allow it to meet its obligations as they fall due. Consequently, the directors consider it is appropriate to present the accounts on a going concern basis.

2.3 Interest income

Interest income is recognised in the Statement of Income and Retained Earnings using the effective interest method.

2.4 Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

2.5 Creditors

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.
