ORDER

BEFORE District Judge Obodai sitting in chambers on 17th November 2021

UPON the application of the Applicant dated 15th November 2021 for a block transfer order

AND UPON READING the papers on the court file recorded as having been read

AND UPON the Court considering it appropriate to make the order without a hearing pursuant to Rule 12.38(1) of the Insolvency (England and Wales) Rules 2016 (the "**Rules**")

IT IS ORDERED that:-

1. Each of the County Court cases listed in the Schedules attached to this order (the "**Schedules**") be transferred to the High Court of Justice, Chancery Division, Manchester District Registry for the purpose only of making this order.

2. Immediately upon this order taking effect, the County Court cases listed in the Schedules be transferred back to the County Court.
3. Diane Dunion (the "**outgoing office-holder**") be removed from office in respect of each of the on-going cases listed in the Schedules (the "**block transfer cases**") from the date of this order.
4. Michaela Samantha Daly (the "**first replacement office-holder**") be appointed as replacement office-holder in respect of each of the cases listed in Schedule 1A, Schedule 2, Schedule 3 and Schedule 4 from the date of this order.
5. David Adam Broadbent (the "**second replacement office-holder**") be appointed as replacement office-holder in respect of the case listed in Schedule 1B from the date of this order.
6. Michael Jenkins (the "**third replacement office-holder**") be appointed as replacement office-holder in respect of the case listed in Schedule 1C from the date of this order.
7. The creditors in each of the block transfer cases shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date this order is sealed. An advertisement containing the information set out in the Schedules shall be sufficient to comply with the requirements of rule 1.6 and Chapter 4 of Part 1 (rules 1.10 to 1.14) of the Rules.
8. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the block transfer cases listed in the Schedules who has an objection to this order shall have 21 days from the date of the publication of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedules unless otherwise ordered by the court.
9. The first replacement office-holder, the second replacement office-holder and the third replacement office-holder (together the "**replacement office-holders**") shall as soon as reasonably practicable give notice of the terms of this order to the Secretary of State and in respect of the liquidations and company voluntary arrangements listed in the Schedules, to the Registrar of Companies.
10. The outgoing office-holder shall file a copy of this order with each of the courts listed in the Schedules.
11. The outgoing office-holder shall receive her release as liquidator or supervisor 21 days after the date of the publication of the advertisement referred to at paragraph 7 of this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 8 of this order, in so far as her release relates to the specific case which is subject to that application.
12. The outgoing office-holder shall receive her release as provided for under paragraph 11 of this order without being required to (i) apply to the Secretary of State for her release or discharge as appropriate pursuant to s.173(2)(b) and s.174(4)(b) of the Insolvency Act 1986 as the case may be or (ii) being required to file a receipts and payments account.
13. The replacement office-holders shall in the next progress report after the date of this order, notify creditors or, in the case of any members' voluntary liquidation, members of the making of this order. In the case of those block transfer cases where the final account or the final report has already been delivered and the statutory time limit for a creditor or a member making any further

representations or applications has expired or will expire within 8 weeks; publication of the advertisement in accordance with paragraph 7 of this order alone shall be deemed sufficient delivery of notice of this order under rule 12.38(6)(b)(i) of the Rules.

14. In respect of each of the block transfer cases where the replacement office-holders are appointed as joint office-holder, any act required or authorised to be done by the joint office-holders may be done by all or any one or more of them.

15. Liberty to apply.
