

The company provides soft courses and projects for people in Walsall in the interest of improving their mental health, well-being, reducing stress and improving their quality of life.

The company trained 9 people within the local community on various activities including sublimation printing, vinyl printing, and other IT software such as the use of Microsoft Office and Photoshop Elements 11. These people have benefited from our activities. These people were from the disadvantaged communities of Walsall. They are able to use basic Photoshop software to create digital craft and print on to fabric. Free training was provided for all these activities.

Five of these people have gone on to develop these skills further with a bid to opening their own business. They are also looking for further training to improve their design skills and look for work within the creative industry.

Following the alteration of our objects last year, we were able to support 12 young people at risk of exclusion to raise their Maths and English attainment. We supported their numeracy skills, problem solving skills, literacy and IT skills.

We provided talking sessions where people could talk about their emotional issues, stress and overall well-being.

We supported over 20 adults in this activity and helped them to find ways to manage and cope with their mental health and emotional issues.
