The amount owed by the directors to the company is repayable on demand and interest has been charged at the HMRC official rate of interest. The directors have elected to consolidate their loan balances for the purposes of the accounts. The opening balance of the loans was £14,941 owing to the company and the directors have repaid that loan and then been advanced £9,233, which is the closing balance. This has been repaid within 9 months of the year end date.
