- · Heighten awareness and improve alertness.

- Promote cognitive development by increased brain function.

The benefits are endless, and the company want to make sure a good sensory environment is accessible to all no matter what age or ability.

The company's first pop-up was at a local Christmas Event on the 9th December 2017. This was with limited equipment as our full equipment range had been delayed in delivery. However, it was successful in that it raised further awareness of the company and its aims. Local families were also able to access a unique play environment whilst visiting the Christmas Event.

During this period the company developed it's branding and marketing materials, including leaflets and website. Increased its social media following to raise awareness of the new local service that was being developed within the community of Torbay.

Through the company's actions in this period awareness has been raised that sensory can benefit all not just a select few. That there is a local service that businesses, organisations, community groups and schools can use that provides all-inclusive play.

Overall this period was spent developing the pop-up service the company wished to offer including the following:

- Sourcing relevant Funding
- The sourcing and purchasing of suitable equipment
- Business training
- Developing the brand and marketing materials
- Raising awareness of the company's aims and goals
