**UPON** the Applicant's application by notice dated 8 December 2023

**AND UPON** the Secretary of State providing an email of no objection to this Application dated 24 November 2023

**AND UPON** the Respondents consenting to the Application

**AND UPON** reading the evidence filed

**IT IS ORDERED THAT:**

**Transfer**

1. The proceedings listed in Schedule 1 to this Order be transferred to the High Court for the purposes of this application only and forthwith after the making of this Order be treated as transferred back to the Court from which they came without any intervening administrative action.

**Bankruptcies**

2. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules, the Applicant be removed from his office as Trustee in Bankruptcy of the individuals identified in Schedule 2 hereto with immediate effect.
3. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36 (2) of the Rules the First and Second Respondent be appointed as joint trustee of the individuals identified in Schedule 3 (with power to act jointly or individually) in place of the Applicant with immediate effect.
4. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36 (2) of the Rules the First Respondent be appointed as joint trustee of the individuals identified in Schedule 4 in place of the Applicant with immediate effect.

**Creditors Voluntary Liquidation**

5. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the Applicant be removed from his office as Liquidator of the companies listed in Schedule 5 as being companies in Creditors Voluntary Liquidation with immediate effect.
6. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the First and Second Respondent be appointed as Joint Liquidators of the companies listed in Schedule 6 (with power to act jointly and individually) in place of the Applicant with immediate effect.
7. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the First Respondent be appointed as Joint Liquidator of the companies listed in Schedule 7 in place of the Applicant with immediate effect.

### **Members Voluntary Liquidation**

8. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the Applicant be removed from his office as Liquidator of the companies listed in Schedule 8 as being companies in Members Voluntary Liquidation with immediate effect.
9. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the First and Second Respondents be appointed as Joint Liquidator of the companies listed in Schedule 9 (with power to act jointly and individually) in place of the Applicant with immediate effect.
10. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the First Respondent be appointed as Joint Liquidator of the companies listed in Schedule 10 in place of the Applicant with immediate effect.

### **Administrations**

11. Pursuant to paragraph 88 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the Applicant be removed from his office as Administrator of the companies listed in Schedule 11 as being a companies in Administration with immediate effect.
12. Pursuant to paragraph 63 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the First and Second Respondents be appointed as Joint Administrator of the companies listed in Schedule 12 (with power to act jointly and individually) in place of the Applicant with immediate effect
13. Pursuant to paragraph 63 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the First Respondent be appointed as Joint Administrator of the companies listed in Schedule 13 in place of the Applicant with immediate effect.

### **Compulsory Liquidation**

14. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Rules, the Applicant be removed from his office as Liquidator of the companies listed in Schedule 14.
15. Pursuant to Section 168(3) of the Act and Rule 12.36(2) of the Rules the First and Second Respondents be appointed as joint liquidators of the companies listed in Schedule 14 (with power to act jointly and individually) in place of the Applicant with immediate effect.

### **Individual Voluntary Arrangements**

16. Pursuant to Section 263(5) of the Act and Rule 12.36(2) of the Rules the Applicant be removed from his office as Supervisor of the Individual Voluntary Arrangements of the individuals listed at Schedule 15 with immediate effect.
17. Pursuant to Section 263(5) of the Act and Rule 12.36(2) of the Rules the First and Second Respondents be appointed as Joint Supervisors of the Individual Voluntary Arrangements of the individuals listed at Schedule 15 in place of the Applicant with immediate effect.

### **Notifications**

18. Service of this application on the Respondents is dispensed with.
19. The First and Second Respondents shall notify the Secretary of State, the Registrar of Companies in respect of the insolvency proceedings listed in Schedules 5, 8, 11 & 14, of this Order as soon as reasonably practicable after it is made.
20. The First and Second Respondents shall ensure that a sealed copy of this Order and every Order which may be made as a result of the Application is lodged with the court having jurisdiction over each case affected by such orders for filing on the court file relating to that case.
21. Within 28 days of this Order, the First and Second Respondents shall give notice of this Order to all the creditors of the companies and individuals listed in the Schedules to this Order by way of composite advertisement in the *London Gazette*.
22. All creditors of the companies, or in the case of any members voluntary liquidation, any member, and individuals listed in the Schedules to this Order shall have permission to apply within 28 days of the said advertisement in the *London Gazette* to vary or discharge this Order insofar as it affects the company, or companies or bankrupts' estates of which they are a creditor. Any such application shall be made on 3 clear days' notice to the First and Second Respondents.
23. The provisions contained in IR r.18.7(4) and r.18.8(3) shall not apply and neither the Respondents nor the Applicant are required to produce any progress reports on the Applicant ceasing to act as an office-holder pursuant to this Order. Each of the insolvencies in the Schedules to this Order shall retain their original reporting dates.
24. The Applicant shall receive his release as office-holder 28 days after filing notice of removal with the Registrar of Companies in the case of such appointments as are as administrator or provisional liquidator, and in the case of such appointments as are as supervisor in accordance with the terms of such arrangement, and otherwise on application to the Secretary of State; save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 22 of this order for the specific case subject to that application.

### **Costs**

25. The costs of this application shall be borne by the First and Second Respondents and neither the Applicant nor the Respondents shall have recourse to the insolvency estates of any of the companies and individuals listed in the Schedules to this Order for the purposes of satisfying their costs of this application.
