The directors consider that there are material uncertainties about the company's ability to continue as a going concern. Due to government agency action subsidiaries of the company were effectively required to dispose of their assets under fire sale conditions.

Whilst the directors are considering the ongoing situation regarding debt owed by these subsidiaries to the company, it is unlikely that creditors will be paid.
