

Report of the Liquidators For The Period From The Commencement Of The Liquidation on 07 January 2021 to 6 January 2022

1. Introduction

Susan Purnell of Purnells, Goldfields House, 18A Gold Tops, Newport, South Wales, NP20 4PH was appointed Liquidator of LC And VB Ltd on 07/01/2021 by the shareholders.

There have been no changes in office holders during the period.

a). The Company Registered Office is:-

2. Receipts and Payments Account

- 2.1 A receipts and payments account is attached at Appendix 2.
- 2.2 That receipts and payments account compares the actual realisations made to date with the estimated realisations set out in the original Declaration of Solvency.

3. Costs of the Liquidation

- 3.1 The receipts and payments account at Appendix 2 sets out details of the payments made to date.
- 3.2 The Liquidators remuneration was agreed on a fixed fee basis of £2,000 plus VAT, at the general meeting held on 07/01/2021.

4. Realisation of Assets

Corporation Tax Refund

A corporation tax refund of £837 was owed to the Company. The sum of £844 has been received.

VAT Refund

A VAT refund of £1,900 was shown in the Declaration of Solvency as owing to the Company.

It has been established that the Company was de-registered for VAT in November of 2018 and the Registration has been redundant since that date. Enquiries will have to be made as to when

the returns were submitted in order to establish whether they have been processed to give rise to the refund due.

HSBC Bank plc

The Declaration of Solvency showed a balance held on the HSBC account of £110,248. The actual sum of £110,212 was received to the date of closure of that account.

S455 Refund

Correspondence has been received from H M Revenue & Customs that the S455 Refund has been acknowledged. Authorisation to pay the monies due has been sent to the relevant department of H M Revenue & Customs and is being actively pursued.

5. Secured and Preferential Creditors

There are no Secured or Preferential Creditors within this Liquidation.

6. Unsecured Creditors

An amount of £2,567 is shown in the cessation accounts as owing to the Director on his loan account. This sum will be repaid shortly.

7. Members Rights

Members with the concurrence of at least 5% of the total voting rights of all members having the right to vote at general meetings of the Company, have the right under Rule 18.9 of the Insolvency Rules 2016 to request further information about remuneration or expenses set out in this report. The request must be made within 21 days of receipt of this report.

Members with the concurrence of at least 10% of the total voting rights of all the members having the right to vote at general meetings of the Company, or with the permission of the court, have the right under Rule 18.34 of the Insolvency Rules 2016 to challenge the Liquidators remuneration, no later than 8 weeks following receipt of this report.
