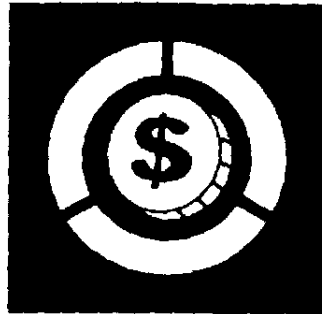




Written Resolutions of Cash Coach Limited
