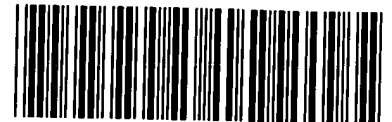

Nova Sports, much like organisations worldwide, had to adapt significantly across this financial period due to the coronavirus pandemic.

Pre-pandemic (Oct 19 – Mar 20), Nova were continuing to build on its strong, positive reputation in the community and serve the needs of people with disabilities through sport and physical activity. Work in schools and running community clubs were successful and holiday activity interest grew.

It should also be noted that Nova's first foray into Bristol occurred with the idea and development of a frame running club and a powerchair football club, supported by Access Sport and Bristol City Football Foundation respectively.

From March 2020 onwards however, Nova ceased all face-to-face activity and two-thirds of staff were furloughed at some point. Instead, activities ran via Zoom (with mixed success) and the Sports Equipment Package Scheme was launched. In summer 2020, 469 sports boxes were hand-delivered to families with a child with a disability. The project was successful in multiple ways, including the amount fundraised, the increased level of partnership working with other organisations, the positive impact it had on families, the ability for Nova to continue to operate and just how much the scheme increased the reach of the organisation to help even more families than before.
