### 6. ULTIMATE PARENT COMPANIES

The Harwell Science and Innovation Campus Nominee No.2 Limited is a wholly owned subsidiary of The Harwell Science and Innovation Campus General Partner Limited.

The Harwell Science and Innovation Campus General Partner Limited is a joint venture company owned 50% by Harwell Oxford Developments (GP) Limited and 50% by Harwell Science and Innovation Campus Public Sector General Partner Limited.

The ultimate holding companies of Harwell Oxford Developments (GP) Limited is BSREP III Caelum Pooling LP.

The Harwell Science and Innovation Campus Public Sector General Partner Limited is a joint venture company owned 50% by the United Kingdom Atomic Energy Authority and 50% by the Science and Technology Facilities Council (STFC). On 1 April 2018 STFC became part of UK Research and Innovation (UKRI), a non-departmental public body funded by grant-in-aid from the UK Government.
