'THAT pursuant to section 641(1)(a) of the Companies Act 2006, the share capital of the Company be and is hereby reduced by £25,000 by:-


- i. the reduction of the issued share capital from £121,550 to £109,050 by the cancellation of 25,000 ordinary shares of £0.50 each; and
