**UPON** the application dated 15 June 2021 ("Application") of David Kerr and Richard Hunt, both of SFP Restructuring Limited of 9 Ensign House, Admirals Way, Marsh Wall, Docklands, London, E14 9XQ

**AND UPON** the hearing having been conducted remotely by Microsoft Teams, the court finding it expedient and necessary to do so to secure the proper administration of justice, but the public having been notified in the Court list

**AND UPON HEARING** by video Ms Anja Lansbergen-Mills of counsel for the Applicants

**AND UPON READING** the evidence

**AND UPON THE COURT NOTING** the representations of the Insolvency Service contained in an email from Benjamin Barker at the Insolvency Service of 09:22 on 21 June 2021 attached to the skeleton argument of the

Applicants' counsel

**IT IS ORDERED** pursuant to section 108 of the Insolvency Act 1986 and Rule 12.36 of the Insolvency (England and Wales) Rules 2016 that:

1. The Respondent, Linda Golding, be removed from office in respect of each of the cases ("Block Transfer Cases") listed in Schedules 1 and 2 of this order with effect from 11:10am on 25 June 2021.
2. The First Applicant, David Kerr, be appointed as replacement office-holder in respect of each of the Block Transfer Cases listed in Schedule 1 of this order with effect from 11:10am on 25 June 2021.
3. The Second Applicant, Richard Hunt, be appointed as replacement office-holder in respect of each of the Block Transfer Cases listed in Schedule 2 of this order with effect from 11:10am on 25 June 2021.
4. The members and creditors (as may be) of the companies listed in Schedules 1 and 2 of this order be notified of this order by
  - (a) advertisement published in the London Gazette within 28 days of the date of this order, such advertisement to include a notice that any member or creditor may within 28 days of the advertisement make an application to Court to set aside or vary the terms of the order; and
  - (b) notice given at the same time as the next report pursuant to statute is made to them.
5. Any member or creditor of the companies listed in Schedules 1 and 2 of this order who has an objection to this order shall have 28 days from the date of advertisement published in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.
6. The Applicants shall give notice to the Secretary of State of the terms of this order as soon as reasonably practicable.
7. The Applicants shall file any appropriate notices in respect of the removal of the Respondent and of the respective appointments of the Applicants with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) and the Registrar of Companies as may be required.
8. Nothing in this order shall release the Respondent from any obligation to give and file notices in respect of her removal under this order in respect of the Block Transfer Cases listed in Schedules 1 and 2 of this order.

9. The Respondent shall receive her release and be discharged from liability as liquidator of the companies listed in Schedules 1 and 2 of this order 28 days from the date of the advertisement referred to in paragraph 4(a) of this order, or such later time as the Secretary of State may determine under s.172(2)(b) Insolvency Act 1986.
10. No order as to costs.
