

You request the provision of the services identified above (the "Bank Services") through HSBC Innovation Banking pursuant to letter of credit applications, cash management services agreements or other bank or financial services agreements executed from time to time by you. To induce HSBC Innovation Banking to provide such Bank Services, you agree to enter into this Deed.

## 1. DEFINITION AND INTERPRETATION

### IN THIS DEED:

1.1 "Deposit" means all deposits now and in the future credited to the Charged Account(s) with HSBC Innovation Banking and any deposit or account of any other currency, description or designation which derives in whole or in part from such deposits or Charged Account(s) and the debts represented by each such deposit;

"Expenses" means all expenses (on a full indemnity basis) incurred by HSBC Innovation Banking at any time in connection with the Deposit or the Secured Obligations or in taking or perfecting this Deed or in preserving, defending or enforcing the security created by this Deed or in exercising any power under this Deed or otherwise, with Interest from the date they are incurred;

"Interest" means interest at the rate(s) notified and charged to you by HSBC Innovation Banking from time to time;

"Required Currency" means the currency or currencies in which the Secured Obligation are expressed from time to time; and "Secured Obligations" means all your present and future obligations and liabilities to HSBC Innovation Banking of any kind and in any currency (whether present or future, actual or contingent and whether incurred alone or jointly and/or severally with another and as principal or as surety or in any other capacity or of any other nature) together with HSBC Innovation Banking's charges and commission, Interest and Expenses.

1.2 Unless the context otherwise requires, any reference in this Deed to:

- a. "HSBC Innovation Banking", "you" or the "Business" includes you and our respective successors in title and assigns;
- b. a "Clause" or "Schedule" is a reference to a clause or schedule to this Deed;

- c. this "Deed" or any other agreement or document is a reference to this Deed or, as the case may be, such other agreement or document as the same may have been, or may from time to time be, amended, varied, supplemental or novated;
  - d. the "Deposit" includes all interest accrued or accruing in the future on it;
  - e. a "person" includes any individual, firm, company, corporation, government, state or agency of a state or any association, trust, joint venture, consortium or partnership (whether or not having separate legal personality);
  - f. a provision of law is a reference to that provision as amended or re-enacted and includes any subordinate legislation; and
  - g. words in the singular include the plural and vice versa and words in one gender include any other gender.
- 1.3 If two or more persons are included in the expression "Business" then the use in this Deed of the word "Business" or "you" shall be deemed to refer to such persons both together and separately and the Secured Obligations shall be your joint and several obligations and each of you shall be primarily liable by way of indemnity for the liabilities to HSBC Innovation Banking of the other or others of you.
- 1.4 If the definition of Deposit refers to more than one deposit or account then the use in this Deed of the word Deposit shall be deemed to refer to such deposits and/or accounts both together and separately.
- 1.5 Interest will be calculated both before and after demand or judgment on a daily basis and compounded according to agreement or in the absence of agreement monthly on such days at HSBC Innovation Banking may select.
- 2. CHARGE**
- You covenant to discharge on demand the Secured Obligations and as a continuing security for the payment and discharge of the Secured Obligations and with full title guarantee charge the Deposit to HSBC Innovation Banking by way of first fixed charge.
- 3. POWERS OF HSBC INNOVATION BANKING**
- 3.1 Despite any term to the contrary in relation to the Deposit HSBC Innovation Banking may at any time without notice (both before and after demand) appropriate, apply or transfer the Deposit or any part of it in discharge of the whole or any part of the Secured Obligations.
- 3.2 Section 93(1) of the Law of Property Act 1925 (restricting the right of consolidation) shall not apply to this Deed.
- 3.3 In addition to any lien or right to which HSBC Innovation

Banking may be entitled by law HSBC Innovation Banking may from time to time without notice and both before and after demand set off the whole or any part of the Secured Obligations against any deposit or credit balance on any of your accounts with HSBC Innovation Banking (including the Deposit) (whether or not that deposit or balance is due to you), and may combine or consolidate any such deposit or credit balance with the whole or any part of the Secured Obligations.

- 3.4 HSBC Innovation Banking may exchange or convert to the Required Currency any currency held or received.

### 4. RESTRICTIONS

Despite any term to the contrary in relation to any deposit or credit balance on any of your accounts with HSBC Innovation Banking (including the Deposit) the Deposit will not be capable of being assigned, dealt with, mortgaged or charged and will not be repayable to you before all the Secured Obligations have been discharged, but HSBC Innovation Banking may without prejudice to this Deed permit you to make withdrawals from time to time. Any withdrawal permitted by HSBC Innovation Banking shall not be deemed to be a release of this security insofar as it concerns the Deposit. The terms of this Deed shall override the terms otherwise applicable to the Deposit.


### 5. APPROPRIATION

- 5.1 Subject to Clause 5.2 HSBC Innovation Banking may appropriate all payments received for your account in reduction of any part of the Secured Obligations as HSBC Innovation Banking decides.

- 5.2 HSBC Innovation Banking may open a new account or accounts upon HSBC Innovation Banking receiving actual or constructive notice of any charge or interest affecting the Deposit. Whether or not HSBC Innovation Banking opens any such account no payment received by HSBC Innovation Banking after receiving such notice shall (if followed by any payment out of or debit to the relevant account) be appropriated towards or have the effect of discharging any part of the Secured Obligations outstanding at the time of receiving such notice.

### 6. REDESIGNATION, RENEWAL OR REPLACEMENT OF THE DEPOSIT

If any account in which the Deposit is held is changed, replaced or redesignated this Deed will apply to any deposit in the new or redesignated account from time to time.

### 7. MISCELLANEOUS

- 7.1 This Deed is a continuing security, will extend to the ultimate balance of the Secured Obligations, and is in addition to any other security (present or future) held by HSBC Innovation Banking for the Secured Obligations and shall not merge with or prejudice such other security or any contractual or legal rights of HSBC Innovation Banking.
- 7.2 You will at your own cost at HSBC Innovation Banking's request execute any deed or document and take any action required by HSBC Innovation Banking to perfect this security or further to secure on the Deposit the Secured Obligations.
- 7.3 No failure to exercise, nor any delay in exercising, on the part of HSBC Innovation Banking, any right or remedy under this Deed shall operate as a waiver, nor shall any single or partial exercise of any right or remedy prevent any further or other exercise or the exercise of any other right or remedy. The rights and remedies provided in this Deed are cumulative and not exclusive of any rights or remedies provided by law.
- 7.4 HSBC Innovation Banking shall not be liable for any loss sustained by you in consequence of the exercise of the rights of HSBC Innovation Banking under this Deed including (but not limited to) any loss of interest caused by the determination before maturity of the Deposit or by the fluctuation in any exchange rate at which currency may be bought or sold by HSBC Innovation Banking.
- 7.5 Any provision of this Deed which is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions of this Deed or affecting the validity or enforceability of such provision in any other jurisdiction.
- 7.6 You represent and warrant that you are not, whether under your registered name in your jurisdiction of incorporation or any other name, registered at the UK Companies Registry as an overseas company under Part 2 of the Overseas Companies Regulations 2009 (SI 2009/1801).
- 7.7 This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

### 8. NOTICES

- 8.1 Any notice or demand by HSBC Innovation Banking may be sent by post, fax, electronic mail or other electronic means (including any attachment) or delivered to you at your address, fax number or electronic address (as appropriate) last known to HSBC Innovation Banking or may also be served personally on any of your directors.


