#### **EPIC Dad Fun Club**

Fun-filled events for dads and male carers to enjoy with their children including refreshments and a variety of games, toys, crafts, and activities for all ages.

#### **EPIC Dad Drop-In**

A baby and toddler group with toys, crafts, snacks, songs, and story time for dads with young children.

#### **EPIC Dad Family Events**

Family meet ups, such as fun days and BBQs, to enjoy food, games together with families.

Through our various groups and engagement with local dads and their families, we have seen men supported and develop their friendship and support networks. Fathers have been empowered in their important role within the family and families have been transformed as dads have strengthened their bond with their children. We are working closely with other community organisations and through these partnerships, having a greater impact in helping dads and male carers be positively involved in the lives of their children.

We now have an 'EPIC Dad Van' which has enabled us to transport equipment to events and items to families in our local communities. Also, it has been a great way to promote the organisation with our logo on the van. We have also opened an 'EPIC Centre' in Risby, near Bury St Edmunds, where we run many of our activities and has become a 'fatherhood hub'.

We often receive feedback at groups and events about what people enjoyed and their ideas of what else we could do to support them more. These evaluation forms, conversations with dads, and feedback on social media, has led to many new activities and developments within existing work.

It is important to us that dads, mums, and the wider family, feel part of the project and how it progresses in line with meeting identified needs. The survival kits for new fathers have been so well received that it has led to us offering Survival Sessions (fatherhood preparation group) alongside it. Also, we have developed more one-to-one work with dads offering the Dads Matter course and have also started the wellbeing walks as a way to support dads who are finding life challenging.

Working closely with other organisations working with families in the area has also helped us to reach more fathers and develop effective partnership relationships such as running a family group (for dads, mums, carers, and young children) with the help of Homestart (a local charity) and partnering with Sharing Parenting (a local CIC) in parenting courses and family events.

We look forward to continuing to develop the work of EPIC Dad and, together with the help of consultations with our stakeholders and partnerships with other organisations, we will see many more fathers, father figures, and families helped, encouraged, and supported. We are committed to our vision of 'restoring the role of fathers' in Suffolk and beyond.
