That the Company's share capital of £100 divided into 100 Ordinary Shares of £1 each be and is re-designated as follows:



- 30 Ordinary shares issued in the name of Mr. David Robert Wiltshire are re-designated into 30 Ordinary 'B' shares of £1 each.
