**UPON THE APPLICATION** by the Applicant dated 20<sup>th</sup> December 2021 (the "Application")

**AND UPON READING** the application notice and the evidence, including the Witness Statements of the Applicant and the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Respondents

**AND UPON** the Court being satisfied that the Order can be made without a hearing.

**IT IS ORDERED** that:

- (1) The Applicant be removed from office as one of the joint liquidators of the companies in creditors' voluntary liquidation and those companies in members' voluntary liquidation, as set out in the Schedule to this Order.
- (2) In place of the Applicant, the First, Second, and Third Respondents be respectively appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation and those companies in members' voluntary liquidation, as set out in the Schedule to this Order.
- (3) By placing a notice (the "Notice") in the London Gazette within 28 days of the date of this Order, the Applicant do notify the creditors and members of each of the companies listed in the Schedule hereto of the making of this Order.
- (4) Any creditor or member of the companies listed in the Schedule to this Order with an objection to the making of the same, do apply to the Court to set aside or vary the terms of this Order within 14 days of date on which the Notice is published in the London Gazette. Any such application shall not affect or vary the block transfer of the cases set out in the Schedule until a further or other order is made by the Court.
- (5) The First, Second, Third, and Fourth Respondents do file any relevant notices concerning the replacement of the Applicant with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) and the Registrar of Companies, as required.
- (6) Nothing in this Order shall release the Applicant from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in the Schedule.
- (7) 14 days after the date of which the Notice is published in the London Gazette, the Applicant be released and be discharged from liability as officeholder in respect of the appointments set out in the Schedule to this Order.
- (8) No order as to costs.
