1 Statutory information

2 Directors' advances, credit and guarantees

During the year the company made an advance of £ 9 843.42 to a director of the company Adrian Sobierajski, £ 5 666.87 to a director of the company Andrzej Mikolajczyk and £ 6 614.18 to a director of the company Krystian Zaucha , to provide advance funds for expences they were expecting to incur. The advance will be balanced over the next period 25/04/2020.

3 Average number of employees

During the period the average number of employees was 0.

For the period ending 31 July 2019 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
