

AND THE COURT being satisfied that the omission to deliver to the Registrar of Companies pursuant to Section 860 of the above-mentioned Act the Legal Charge dated 1 February 2019 in favour of the Claimant against the Defendant's property 18 Princess Street Bollington Cheshire SK10 5HZ together with the prescribed particulars thereof was due to inadvertence and that it is just and equitable to grant relief pursuant to Section 859F of the Companies Act 2006 (Amendment of part 25) Regulations 2013 of the Act ORDERS that the time for delivering to the Registrar of Companies for registration the Legal Charge dated 1 February 2019 and made between The Mortgage Work (UK) PLC and Porro Holdings Limited together with the prescribed Particulars thereof be and the same is hereby extended to 4 pm on the date 21 days of the date of this order.
