

ORDER

BEFORE District Judge Richmond sitting in chambers on 3 July 2023

UPON the application of the Applicants dated 30 June 2023 for a block transfer order

AND UPON READING the papers on the court file recorded as having been read

AND UPON the Court considering it appropriate to make the order without a hearing pursuant to Rule 12.38(1) of the Insolvency (England and Wales) Rules 2016 (the "**Rules**")

IT IS ORDERED that:-

- Each of the County Court cases listed in Schedule 1 attached to this order (the Schedule) be transferred to the High Court of Justice, Chancery Division, Manchester District Registry for the purpose only of making this order.
- Immediately upon this order taking effect, the County Court cases listed in the Schedule be transferred back to the County Court.
- 3. David Farmer (the **Outgoing Office-holder**) be removed from office in respect of each of the ongoing cases listed in the Schedule (attached to this order) (the **Block Transfer Cases**) and be

replaced by the individual or individuals referred to in the Schedule as the "Proposed Replacement IP" being Paul Robert Appleton (the 1st Respondent), Wayne Macpherson (the 2nd Respondent), Dominik Thiel-Czerwinke (the 3rd Respondent), Jamie Taylor (the 4th Respondent), Louise Donna Baxter (the 5th Respondent), Jacob Beake (the 6th Respondent) and Jeremy Karr (the 8th Respondent) (together **the Replacement Office Holders**) as set out at paragraphs 4 to 9 below.

- 4. The Outgoing Office-holder be removed from office as Joint Administrator of the company in administration listed in Schedule 1 Part 1 attached hereto and with effect from the date of this order and Paul Robert Appleton (the 1st Respondent) be appointed as the replacement Joint Administrator of that company with effect from the same date, pursuant to paragraphs 63, 91 and 95 of Schedule B1 to the Insolvency Act 1986 (the Act) and rule 12.36(2) of the Rules.
- 5. The Outgoing Office-holder be removed from office as Joint Trustee in bankruptcy of the bankruptcy estate listed in Schedule 1 Part 2 attached hereto and with effect from the date of this order Jeremy Karr, the 8th Respondent, be appointed as replacement Joint Trustee in bankruptcy of the said bankruptcy estate with effect from the same date, pursuant to Sections 298 and 303 of the Act and rule 12.36 (2) of the Rules.
- 6. The Outgoing Office-holder be removed from office as Joint Liquidator of the companies in creditors voluntary liquidation listed in Schedule 1 Part 3 attached hereto and with effect from the date of this order and where indicated the individual named as "Proposed Replacement IP" in Schedule 1 Part 3 for each case be appointed as the replacement Joint Liquidator of that company with effect from the same date, pursuant to Section 108 of the Act and rule 12.36 (2) of the Rules.
- 7. The Outgoing Office-holder be removed from office as Joint Liquidator of the companies in members voluntary liquidation listed in Schedule 1 Part 4 attached hereto and with effect from the date of this order and Jamie Taylor (the 4th Respondent) be appointed as the replacement Joint Liquidator of that company with effect from the same date, pursuant to Section 108 of the Act and rule 12.36 (2) of the Rules.
- 8. The Outgoing Office-holder be removed from office as Joint Liquidator of the companies in compulsory liquidation listed in Schedule 1 Part 5 attached hereto and with effect from the date of this order and Jamie Taylor (the 4th Respondent) be appointed as the replacement Joint Liquidator of those companies with effect from the same date, pursuant to Section 172 of the Act and rule 12.36 (2) of the Rules.
- 9. The creditors in each of the Block Transfer Cases shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date this order is sealed. An advertisement containing the information set out in the Schedule shall be sufficient to comply with the requirements of rule 1.6 and Chapter 4 of Part 1 (rules 1.10 to 1.14) of the Rules.
- 10. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the block transfer cases listed in the Schedule who has an objection to this order shall have 21 days from the date of the publication of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedule unless otherwise ordered by the court.
- 11. The Replacement Office-holders shall as soon as reasonably practicable give notice of the terms of this order to the Secretary of State and in respect of the liquidations and company voluntary arrangements listed in the Schedules, to the Registrar of Companies.
- 12. The Outgoing Office-holder shall file a copy of this order with each of the courts listed in the Schedule.
- 13. The Outgoing Office-holder shall receive his release as administrator, liquidator or trustee in bankruptcy 21 days after the date of the publication of the advertisement referred to at paragraph 9 of this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 10 of this order, in so far as his release relates to the

specific case which is subject to that application.

- 14. The Outgoing office-holder shall receive his release as provided for under paragraph 11 of this order without being required to (i) apply to the Secretary of State for his release or discharge as appropriate pursuant to s.173(2)(b), s.174(4)(b) and s. 299 of the Insolvency Act 1986 as the case may be or (ii) being required to file a receipts and payments account.
- 15. The Replacement Office-holders shall in the next progress report after the date of this order, notify creditors or, in the case of any members' voluntary liquidation, members of the making of this order. In the case of those block transfer cases where the final account or the final report has already been delivered and the statutory time limit for a creditor or a member making any further representations or applications has expired or will expire within 8 weeks; publication of the advertisement in accordance with paragraph 10 of this order alone shall be deemed sufficient delivery of notice of this order under rule 12.38(6)(b)(i) of the Rules.
- 16. In respect of each of the block transfer cases where the Replacement Office-Holders are appointed as joint office-holder, any act required or authorised to be done by the joint officeholders may be done by all or any one or more of them.
- 17. Liberty to apply.
