Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 ("2006 Act"), the board of directors of the Company ("Directors") propose that the resolutions ("Resolutions" and each a "Resolution") below are passed as indicated below.

Ordinary Resolution

THAT, in accordance with section 551 of the 2006 Act, the Directors be generally and unconditionally authorised to allot an additional 9,316 ordinary shares of nominal value £0.01 each in the capital of the Company up to an aggregate nominal amount of £93.16 PROVIDED THAT this authority shall, unless renewed, varied or revoked by the Company, expire on 30 September 2020.

This authority revokes and replaces all unexercised authorities previously granted to the Directors but without prejudice to any allotment of shares already made or offered or agreed to be made pursuant to such authorities.

Special Resolution

- THAT, subject to the passing of resolution 1 and in accordance with section 570 of the 2006 Act, the Directors be generally empowered to allot equity securities (as defined in section 560 of the 2006 Act) pursuant to the authority conferred by resolution 1 (and also with any relevant consents required by the Company's shareholders agreement obtained), as if the pre-emption rights contained in section 561(1) of the 2006 Act did not apply to any such allotment, provided that this power shall:
 - a) be limited to the allotment of equity securities up to an aggregate nominal amount of £93.16; and
 - b) expire on 30 September 2020 (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry make an offer or agreement which would or might require equity

securities to be allotted after such expiry and the director may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.
