Company activities and impact

Pamodzi Means Together. Our mission is to celebrate inspirational stories and collaborate with creatives to challenge, affirm and inspire.Pamodzi has three focus areas; It celebrates inspirational women in our community and contributes to community well-being by celebrating women whilst supporting the work of the Portsmouth Abuse & Rape Counselling Service (PARCS) www.parcs.org.uk. A short film about this year's event is available at https://www.youtube.com/watch?v=2JQB3JCVY38.Our Community Collaborations lean into challenging conversations and inspire people to listen and have this year hosted cross-cultural story-telling projects. Our Creative Schools Work facilitates creative expression inspired by the curriculum. Company Activities Update on Company DirectorsRoni Edwards continues to be a Director of Pamodzi Creatives CIC alongside Amy Doyle for the period 1st October 2020 to 30th September 2021. Community Collaborations The impact of Covid and Lock-down throughout this accounting year greatly impacted on the company's opportunity for community collaborations. The Inspirational Women of Portsmouth ProjectEach year, we create a social media campaign integrating short films and podcasts celebrating local women. This is part of the lead up to our annual celebration for International Women's Day - the Pamodzi Inspirational Women of Portsmouth Awards. Working towards an International Women's Day Award event, a social media campaign integrates short films, podcasts and a nomination process where anyone can nominate any individual identifying as a woman/girl considered inspirational because of the positive impact they have made within their community, whatever the context. Given the challenge of lock-down, the 2021 award event took place online and was funded through a Crowd-funder and award sponsors. Over 200 nominations were submitted across 13 categories. 6 local trailblazers from the community were on the selection panel with finalists announced in February followed by the online award event on 7 March. The trophy awards were commissioned by local artists Shake Your Glass. Post lock down, our finalists were able to participate in a photography project celebrating them. Pamodzi has also co-founded Platform Network; a women's networking initiative that will meet quarterly Community ProjectsMen's Mental HealthA short story telling film was developed to uncover the sometimes difficult topic of mental health amongst men. Due to lock-down challenges, we were only able to launch the film online on International Men's Day. This project was in collaboration with The Dad's Club, My Boy Can, Over the Hill productions, Voyage Creative & Liberty Lounge and will aim to raise funds for an additional men's mental health specialist Talking Change. Apprenticeship Scheme Beyond the involvement of our two Youth Advisors, the impact of lockdown limited our opportunities to build on our apprenticeship scheme. A young person was contracted to work on the Inspirational Women of Portsmouth online event. Creative Schools WorkCurriculum-led DanceThe impact of lockdown limited our opportunities to deliver schools work. In the periods that lock-down was lifted and schools were open, Pamodzi worked with Portsmouth & Southampton school Sports partnerships delivering bespoke curriculum-led dance through the Laban movement analysis framework. Creative Transitions Project The Creative Transitions project was delivered in September 2021. We were able to secure funding that would support four Key Stage 2 and 3 schools to creatively explore wellbeing themes as part of their post-lock down transition back to school. We Shine Festival Pamodzi was contracted in the schools engagement strand of Portsmouth Creates We Shine Autumn festival. This involved facilitating a programme of work for three schools that worked with artists to creatively celebrate the city. Animation artists, dancers and graffiti artists were involved in this project.

Alongside working with our Community Advisory Board, the Pamodzi Directors have ensured they engage the public and relevant representatives in a number of ways. Whilst organising the online Inspirational Women of Portsmouth Celebration we ensured a mixed representation of the community were involved in the planning of the project.
