### Company activities and impact

Pamodzi Means Together. Our mission is to celebrate inspirational stories and collaborate with creatives to challenge, affirm and inspire. Pamodzi has three focus areas; It celebrates inspirational women in our community and contributes to community well-being by celebrating women whilst supporting the work of Endometriosis South Coast. Our Community Collaborations lean into challenging conversations and inspire people to listen and have this year hosted cross-cultural story-telling projects. Our Creative Schools Work facilitates creative expression inspired by the curriculum. For the period submitted, the company was able to focus on schools dance delivery as the main income stream. Additionally, the company also secured a contract with Portsmouth City of Sanctuary that delivers activities and coordinates transportation for the refugee and asylum seeker community. The Inspirational Women of Portsmouth Project Each year, we create a social media campaign integrating short films and podcasts celebrating local women. This is part of the lead up to our annual celebration for International Women's Day - the Pamodzi Inspirational Women of Portsmouth Awards. Working towards an International Women's Day Award event, a social media campaign integrates short films, podcasts and a nomination process where anyone can nominate any individual identifying as a woman/girl considered inspirational because of the positive impact they have made within their community, whatever the context. The 2022 award event took at the Royal Maritime Club. Over 180 nominations were submitted across 13 categories. 6 local trailblazers from the community were on the selection panel with finalists announced in February followed by the Award event on 11 March. The trophy awards were commissioned by local artists Shake Your Glass. Pamodzi has also co-founded Platform Network ; a women's networking initiative that will meet quarterly .Community Projects: Wearing Mum's Makeup Apprenticeship Scheme Curriculum-led Dance Octopus Story Project
